MINUTES OF February 15, 2006

TRINITY COUNTY RESOURCE CONSERVATION DISTRICT

Spear mentioned that Secretary of Agriculture, Chuck Conner, announced \$40 million for one-time payment adjustments that will allow eligible Environmental Quality Incentives Program (EQIP) participants to complete conservation practices that have been delayed because of recent increases in energy prices. The one-time adjustment will apply to participants who signed EQIP contracts in 2004 or earlier. The increase in payment will apply to specific practices that have been most affected by spikes in the cost of concrete, steel, plastic pipe, and other construction materials. The increase will only be paid for practices that are completed between March 1 and June 30, 2006.

NRCS will see a small reduction in base funding in the 2007 Budget. The Wetland Reserve Program will see additional dollars, while funding for the Farm Bill program will remain the same. RC&D did not fair as well, with Coordinator positions to be cut by 50%.

O'Sullivan reported Members of the BLM's Northwest California Resource Advisory Council toured the Weaverville Community Forest and Trinity River Lumber Mill on Feb.15th.

5.10 Grass Valley Creek-John Condon

The Lowden Field Wetlands Enhancement Project is proceeding without any major problems. We have received a nationwide permit from the Army Corps of Engineers. DWR staff contacted the Division of Water Rights (SWRCB) to confirm that a water right **does exist** at the state property where Lowden Field Wetlands will be constructed this spring. We will now proceed with a 401-certification application from the North Coast Regional Water Quality Control Board.

5.20 Fuels Reduction Projects

RCD fuels crews were laid off on January 26. NEPA and CEQA must be done on all pending fuels reduction projects before they can commence.

5.25 Weaver Basin Wetlands

Trinity County Planning, NRCS and RCD personnel met at the Weaver Basin Wetlands to discuss the repair of damage to the wetlands from the January 1st storm, how to minimize further damage from future large storm events and to discuss additional enhancement work that can be done.

A field trip to the wetlands sponsored by the Trinity County RC&D in association with the Weaverville & Lewiston Trails groups occurred on February 11 at 10am. Participants observed the new timber bridge placed at the wetlands in October and the plantings.

The kiosk/sign for the wetlands is being worked on by Erick Flikwir and is near completion.

5.30 Revegetation Coordinator's Report – Berna Cooney

Planting

- Hocker Flat- All five of the riparian areas have been successfully installed with the use of the Stinger, a heavy equipment appendage that looks like a giant pair of tweezers that places the six foot long cutting stakes into the water table.
- Weaver Basin Wetlands-Twenty of each of three species of willow (red, shiny and arroyo) from
 rooted stock were planted into the berm of Lance Gulch to mitigate a breach. An additional 39
 white alders were planted to provide additional habitat structure and a future visual barrier
 between the wetland and nearby homes. Forty-eight black cottonwoods were also planted to
 provide for wildlife habitat. We expect to complete more enhancement plantings this season.
- Weaver Bally homeowner's association- The common area to the housing development across from the Trinity High School was planted with 100 white alders, 100 Douglas fir and 400 ponderosa pine with the assistance of a half dozen volunteers.

Trinity County Weed Management Cooperative

• The cooperative members supported the idea to create slides to be shown prior to each movie advising the general public on issues regarding weed control.

- The members also supported the idea to install a split plot design to determine whether spraying with a non-synthetic herbicide in combination with native grasses/forbs as one treatment, flaming in combination with native grasses/forbs as a second treatment and solely native grasses/forbs as a third treatment to test the efficacy of each treatment to compete with yellow starthistle.
- The members also agreed to set up several pilot test plots to test the efficacy of controlling many of Trinity County's invasive weeds using the non-synthetic herbicide consisting of 20% acetic acid (vinegar) and 8% citric acid (lemon juice). The mode of action of this non-synthetic herbicide is desiccation.

Planting Designs

 Two planting designs were created for the upland areas of Hocker Flat and were accepted by Jim Smith. Implementation will begin next week.

5.35 PEIR

RCD and BBWA continue to work with the CDF team on the development of the Vegetation Management PEIR. BBWA members have been researching and developing the range of alternatives to be considered and continue to look at thresholds (mostly as they relate to cumulative impacts). In the most recent tele-conference, the major topic was the issue of CEQA lead agency. A decision on whether the lead agency role will be played by CDFG or the Board of Forestry should be determined shortly. If the lead agency shifts to the Board of Forestry, it will require a new Notice of Preparation (NOP), which may result in a request for additional funds for the RCD contract.

5.40 Project Implementation Coordinator's Report – Cynthia Tarwater

South Fork of the Trinity River

- Completed 2004-05 Monitoring Report for 319(h) State Water Quality Control Board for the South Fork. The Final report for this grant will be done by this summer.
- Assisted with the 2007 Request for Proposals (RFP's) from State Water Quality Control Board for the Trinity and South Fork TMDL Implementation for the Consolidated Grant Process.
- Planning for RFP's due in February and March for the RAC and CA Dept. of Fish and Game.

5.50 Grant Coordinator's Report – Noreen Doyas

Five of our proposals to the California Department of Fish and Game have been approved for funding. These include Hidden Valley Road Decommissioning (\$320,866), Smoky Road Hydroclosure (\$65,494), Grass Valley Creek Gravel Supplementation (\$15,193), Reading Creek Fish Passage Enhancement (\$45,243), and Salmonid Riparian Education Project (\$24,954). Five proposals are on the "Contingency List" including Rattlesnake Creek Road Storm-proofing (\$100,345), Lower Trinity Road Inventory (\$78,018), Weaverville Community Forest Sediment Reduction (\$26,717), Monitoring Grass Valley Creek Watershed Revegetation (\$39,394), and East Branch Irrigation Ditch Piping (\$30,427). One proposal was not funded, Corral Creek Watershed Restoration (\$163,937).

Our proposal to the California Integrated Waste Management Board's Farm and Ranch Illegal Dumpsite Cleanup & Abatement Grant Program has been recommended for funding. It will be presented at their Board Meeting on March 14th. This project includes 11 sites and addresses illegal dumpsites in the Mad River Ranger District, Weaverville Ranger District, Big Bar Ranger District, and Lower Trinity Ranger District, as well as Sierra Pacific Industries and a private landowner for a total cost of \$64,949.

Submitted four proposals to the California Fire Safe Council including East Weaver Shaded Fuel Break (\$63,457), Oregon St/Grass Valley Creek Watershed Fuels Reduction Project (\$95,000), Down River Communities Fuels Reduction Project (\$55,000), and Trinity County Fire Safe Council Planning and Outreach Project (\$24,955).

Submitted two concept paper applications to the State Water Resources Control Board's Consolidated Grants Program. One for \$675,000 for Trinity River TMDL Implementation and another for \$135,000 for the Weaver Basin Watershed Management Plan.

Submitted a proposal for \$4,480 to the Sierra-Cascade Regional Nutrition Network for the Weaverville Summer Day Camp Nutritional Enhancement Project. Nancy Small and Jessie Oliver, our Watershed Stewards members, who will be leading the day camp this summer, developed this proposal.

Staff (Doyas, Westermeyer, and Sheen) are working on completing the Upper Trinity River Watershed Management and Action Plan, and continue to organize project and work plan ideas for a number of Requests for Proposals scheduled for submittal between now and March.

5.60 GIS Specialist – Kelly Sheen

In January, GIS and IT time was allocated to the following projects:

- Provided GIS support for the Graham Matthews Associates sediment source analysis of the Upper Trinity Watershed. Primary tasks completed to this end were 1) identification and digitizing of undocumented harvest areas from recent aerial photography, 2) geo-statistical analysis of updated harvest layer, and 3) secondary comparative analysis of road and harvest layers using modified USFS methodology. These activities are a part of the Upper Trinity River Watershed Assessment project – SWRCB (83 hours - Acct. #: 63).
- GIS development, data coordination, cartographic layout, and map production to support Kenneth Baldwin's Fuel and Fire Management Plan for the Down River Fire Safe project – USFS (31.5 hours - Acct. #: 59).
- GIS development, data coordination, and meeting attendance with BBWA and CDF officials for the statewide Programmatic Environmental Impact Report project CDF (13.5 hours Acct. #: 142).
- GIS development, layout, and report map production for the South Fork Trinity River Watershed Restoration project SWRCB (9 hours Acct. #: 57).
- GIS development and spatial analysis to support the sediment source analysis component of the Rush Creek Watershed Analysis. This effort is a part of the District's Trinity County Watershed Coordinator project BOR (8 hours Acct. #: 137).

- Final corrections and proof approval for the second commercial printing of the updated *"Weaver Basin Trail: A Trail Through Time..."* brochure (6 hours - Acct. #: 12).

5.70 Other Projects/Issues

RCD crews spent 2 days chipping logging slash at Lowden Park and at the State Farm Insurance building. The piles were chipped as part of the Community Chipper Grant Program funded by the North Coast Air Management District. One load of chips was donated to the Community Garden behind Lowden Park to be used on the trail system in the garden. In both cases the slash likely would have been burned, if the chipper program didn't exist.

Spear reported on the status of the EQIP 2006 process. Seven contracts in Trinity County have been approved and obligated. He noted the contract process was accelerated by 3 months this year. Four of the seven funded projects involve livestock operations, while the other three focus on forestry.

Spear described working with the District to address weed management issues on grazing land within the Hayfork Valley. While the District has limited experience with this resource

concern, NRCS funding requires a broad approach to management. Partnering with Larry Forero from UC Extension, NRCS and the District are exploring the potential and criteria for integrated pest management projects. Frost described the rigorous monitoring of plants, water and soils necessary to identify possible impacts of various practices. Local groups involved include the RCD, Weed Management Cooperative, RC&D, CDF, Nor El Muk tribe amd the County Agriculture Commissioner. The RC& D Council will submit the NRCS application.

Frost noted the District has received the first BLM task order in the amount of \$10,000. This funding will be used to layout phase 1 of the project. 5.10 Grass Valley Creek--John Condon

The Lowden Field Wetlands Enhancement Project is proceeding without any major problems. We have received a nationwide permit from the Army Corps of Engineers. DWR staff contacted the Division of Water Rights (SWRCB) to confirm that a water right **does exist** at the state property where Lowden Field Wetlands will be constructed this spring. We have now submitted a 401-certification application to the North Coast Regional Water Quality Control Board.

5.20 Fuels Reduction Projects

RCD fuels crews were laid off on January 26. NEPA and CEQA must be done on all pending fuels reduction projects before they can commence.

5.25 Weaver Basin Wetlands

The kiosk/sign for the wetlands is being worked on by Erick Flikwir and is near completion.

5.30 Revegetation Coordinator's Report – Berna Cooney

Planting

Hocker Flat- Two upland areas designed by the RCD incorporating 16 different native species and a mulch/seed demonstration trial has been completed. A great deal of positive feedback from both the landowner and the TRRP representative has been received.

Planning

Met with the Agriculture Commissioner, Airport Manager and Personnel from the Planning Department regarding the installation of the yellow starthistle competition test trial. Visits to both the Hayfork and Weaverville Airports are scheduled for March 9th to delineate the test sites.

Monitoring the species composition and location of the propagules planted at Hocker Flat using GPS units is scheduled to begin with the assistance of a NRCS representative (Tiffany Riess) the second week of March.

Organization

All planting supplies stored in GVC along with the seed previously stored in office have been relocated into the container beside the Revegetation Office.

Proposals

Two proposals have been created on behalf of the Trinity County Weed Management Cooperative and submitted to the RAC and CDFA. The same proposal idea was discussed with Jim Spear, Bruce Williams and Noreen to be submitted by Bruce with Noreen's assistance to the USDA-Conservation Innovation Grants Program and the USDA-Management and Control of Invasive Species Affecting Grazing Land Program.

Reports

A report was sent to the TRRP outlining the revegetation activities that took place at each of the four bridge sites.

Personnel Both Brian Stewart and Aaron Smith have been laid off.

5.35 PEIR

The Board of Forestry will be the CEQA lead agency. We are waiting to see if this will require a new Notice of Preparation (NOP). If it does, and there are substantial delays and/or additional tasks, we will begin to discuss a request for additional funds for the RCD contract.

5.40 Project Implementation Coordinator's Report – Cynthia Tarwater

South Fork of the Trinity River

- Completed 2007 RAC Request for Proposal's (RFP's) for 4 projects in the South Fork of the Trinity River watershed, including 2 road decommissions, 1 road upgrade and 1 revegetation project. These are due in March. If they are funded the work would be implemented in 2007-09. The Sub-Committee also recommended that the District be awarded \$58,000 in Carryover from 2005 for work on two roads in the Hidden Valley Compartment; if approved, this project would have to be implemented in 2006.
- Completed 2007 Request for Proposals (RFP's) from State Water Resources Control Board for the South Fork and the mainstem Trinity River. This work, if funded, would be implemented in 2007-09.
- Begin planning for upcoming CA Dept. of Fish and Game RFP's, which will be due in March.
- The District has been notified that we have been awarded \$385,000 from CA Department of Fish and Game, \$255,000 from the EPA and \$309,000 from the CA OHMV Commission, for a number of road-related projects in the South Fork of the Trinity River Watershed. This work will contracted this year and next.

5.50 Grant Coordinator's Report – Noreen Doyas

Our proposal to the Sierra-Cascade Regional Nutrition Network for the Weaverville Summer Day Camp Nutritional Enhancement Project for \$4,480 has been approved with some slight modifications. Nancy Small and Jessie Oliver, our Watershed Stewards members, who will be leading the day camp this summer, developed this proposal.

Submitted five proposals for Public RAC funds. Two of them are from the Trinity County Weed Management Cooperative; Yellow Starthistle Competition Pilot Test Trial (\$11,625) and Combating the Chemical Warfare that Spotted Knapweed Engages Upon Native Plant Species (\$33,000). The other three proposals are being submitted by the Trinity County Resource Conservation District; Trinity Alps Wilderness Trail Clearing-Phase III (\$16,000), South Fork Trinity River Watershed Revegetation (\$15,000), and Revegetate Invasive Weed Removal Project (\$16,313).

Working with Jim Spear and Bruce Williams on a proposal for the Grazing Land Conservation Initiative (NRCS funds). These projects are a minimum of \$50,000, require a 50% non-federal match, and are due March 24th. Trinity Resource Conservation & Development Council will be the applicant for this project, which will target tribal members in the Hayfork Valley.

Working on completing the Upper Trinity River Watershed Management and Action Plan, and continuing to organize project and work plan ideas for a number of Requests for Proposals scheduled for submittal this month.

5.60 GIS Specialist - Kelly Sheen

In February, GIS and IT time was allocated to the following projects:

- GIS development, cartographic layout, and map production to support Kenneth Baldwin's Fuel and Fire Management Plan for the Down River Fire Safe project – USFS (80.5 hours -Acct. #: 59).
- Provided GIS support to Graham Matthews Associates on their sediment source analysis of the Upper Trinity Watershed. Primary tasks completed to this end were 1) various general geo-statistical analyses, and 2) layout and electronic production of GMA report graphics. These activities are a part of the Upper Trinity River Watershed Assessment project – SWRCB (21.5 hours - Acct. #: 63).
- GIS development, layout, and report map production for the South Fork Trinity River Watershed Restoration project SWRCB (9.5 hours Acct. #: 57).



5.10 Grass Valley Creek-John Condon

The Lowden Field Wetlands Enhancement Project is proceeding without any major problems. We have received a nationwide permit from the Army Corps of Engineers. DWR staff contacted the Division of Water Rights (SWRCB) to confirm that a water right **does exist** at the state property where Lowden Field Wetlands will be constructed this spring. We have now submitted a 401-certification application to the North Coast Regional Water Quality Control Board.

We are thinking about having another DG give away the first Saturday of May.

Lewiston Little League volunteers and the RCD coordinated the delivery of 30 CY's of DG to be used at the ballpark for infield improvement the last Saturday of March.

5.20 Fuels Reduction Projects

RCD fuels crews are back working on the Covington Mill Fuels Reduction Project and should finish by the end of April. This project was stopped in the winter, due to snow and start up was slightly delayed while USFS resolved NEPA issues regarding "survey & manage" under the Northwest Forest Plan. USFS staff in Weaverville worked quickly and had the project cleared as soon as the snow melted.

RCD and USFS at Lower Trinity Ranger District are discussing the prioritization of the final week of work to be accomplished on USFS lands in the Salyer Heights area with existing funds. The project was unable to be completely finished as planned due steep unstable ground, inclement weather and long commuting delays (due to the Burnt Ranch Slide). Approximately 75% of the project will be completed. It is possible that the Lower Trinity Ranger Dsitrict will have additional funds (RAC) for the coming field season.

CEQA (categorical exemptions) has been completed on five fuels reduction projects that will be implemented over the next 18 months. Project areas include Grass Valley Creek (in the vicinity of Oddfellows) and Oregon Street, Poker Bar, Lower South Fork Road, Downriver Communities of Salyer, Hudson Creek and Hawkins Bar and finally Rush and Bear Creek communities. All of these projects are being funded by the California Fire Safe Council.

5.25 Weaver Basin Wetlands

The kiosk/sign for the wetlands is being worked on by Erick Flikwir and is near completion. The District is in final negotiations with CalTrans for a cooperative agreement to provide supplemental funding for the wetland as mitigation for about 3,000 square feet of wetland impacts at the Rocky Point project. Jessie Oliver, WSP member, is starting a weekly bird count at the wetlands.

5.30 Revegetation Coordinator's Report – Berna Cooney

Proposals

The proposal outlining the ability of active carbon to bind to the phytotoxins produced by spotted knapweed and thereby facilitating native plant establishment was funded for \$13,850 for FY 2007

through the RAC. I believe the proposal was successfully funded, because of Mr. John Rourke's positive remarks at the RAC meeting.

Assisted Bruce Williams in writing a proposal to the USDA-Management and Control of Invasive Species Affecting Grazing Land Program for a total request for funding of \$50,000.

Reports

A report was sent to the Trinity County Planning Department outlining the revegetation activities that have taken place at the Weaver Basin Wetlands.

Monitoring

NEEM Oil is not very effective in the eradication of powdery mildew. A new product consisting of a strain of *Bacillus* is being tested upon the red fescue.

A letter informing the residents affected by the Lowden Fire of the EQIP Program is being formulated with the assistance of Tiffany in the hope we can find a home for all our healthy containerized conifers.

Working with Mark Lockhart to test the efficacy of the non-synthetic herbicide consisting of acetic acid and citric acid upon many of our invasive weed species this spring.

TCWMC

Received permission from U.C. Davis Weed Department to use their photo of the developmental stages of yellow starthistle inflorescence to show at the movie theater to inform residents of the optimum time to mow.

Personnel

Berna will be working 15 to 20 hours a week to stretch funding dollars.

5.35 PEIR

The Board of Forestry will be the CEQA lead agency. We are waiting to see if this will require a new Notice of Preparation (NOP). If it does, and there are substantial delays and/or additional tasks, we will begin to discuss a request for additional funds for the RCD contract. Rneither RCD or BBWA staff spent any time on this project during the last month. One of the complications at the Boar dof Forestry is that they have not had a quorum recently.

South Fork of the Trinity River

• Submitted four South Fork 2006-07 RAC Proposals totaling \$203,000 for consideration in late March. These included two decommissions in Hidden Valley (1N11C and 1N24B), one decommission in the Sims Fire area (4N13A) and one road upgrade (1N11).

- Preparing materials for the Requests for Proposals (RFP's) to California Department of Fish and Game and the state OHV Commission, the RFP's will be due sometime in May.
- With assistance from the USFS in Hayfork we are re-evaluating what has and has not been completed from the Environmental Assessments (EA) including: East Fork/Smoky (1999), Upper South Fork/Happy Camp (2000), Hidden Valley (2005) and the Sims Fire (2006) area in Hyampom.

5.50 Grant Coordinator's Report – Noreen Doyas

Two of the five proposals we submitted for Public RAC funds have been approved. Combating the Chemical Warfare that Spotted Knapweed Engages Upon Native Plant Species (\$13,850) and Trinity Alps Wilderness Trail Clearing-Phase III (\$16,000). All three proposals we submitted for RAC Roads were approved. These include: Hidden Valley Decommission (\$118,000), Lemonade Springs (1N11) Upgrade (\$35,000) and Sims Decommission (\$50,000).

Worked with Jim Spear and Bruce Williams on a proposal for the Grazing Land Conservation Initiative (NRCS funds) for the development and implementation of an Integrated Pest Management Plan that will address yellow starthistle control and prevention strategies, ecosystem management and adaptive management techniques for grazed lands in the Hayfork Valley for \$50,000 (and a \$50,000 non-federal match). Trinity Resource Conservation & Development Council is the applicant for this project and the University of California Cooperative Extension Service is a key partner.

The California Fire Safe Council approved two of the five proposals we submitted, Oregon Street /Grass Valley Creek Watershed Shaded Fuel Break Project (\$95,000) and Down River Communities Fuel Reduction (\$55,000). These areas both recently had Fire/Fuel Management Plans completed by Kenneth Baldwin. The former is closely inked to BLM lands in GVC and the latter to USFS projects in the Lower Trinity District of Six Rivers NF.

Attended the Trinity County Illegal Dumping Ad Hoc Committee Meeting. The next meeting is scheduled for April 20, 2006 at 10am. We had just received word that our Third application to the Integrated Waste Management Board had been approved.

RCD staff has been working with consulting foresters Baldwin, Blomstrom, Wilkinson & Associates and BLM staff in the preparation of the first timber sale in the Weaverville Community Forest. We are hoping to have the plan complete for BLM and community review by the end of May. The actual timber sale should occur sometime this summer.

Two water conservation pipeline projects were completed by RCD crews this past week on West Tule Creek and on Price Creek. Both projects were funded by Fish and Game.

RCD crews were asked to assist the RC&D and the community garden in helping expand the size of the garden using grant funds from the State Association of RC&D's. The expansion will add about 3,000 square feet to the facility. We also might be able to supply a backhoe to help improve the drainage on the site and donate surplus irrigation supplies as well as wet straw bales (for soil amendments to create organic matter) from past RCD projects.

RCD crews were asked to perform a small fuels reduction project for a private landowner in Timber Ridge using a fee for service agreement. The project involves burning several small piles and removing brush and small diameter trees.

5.10 Grass Valley Creek--John Condon

The Lowden Field Wetlands Enhancement Project is proceeding without any major problems. We have received a nationwide permit from the Army Corps of Engineers. DWR staff contacted the Division of Water Rights (SWRCB) to confirm that a water right does exist at the state property where Lowden Field Wetlands will be constructed this spring. We have now submitted a 401-certification application to the North Coast Regional Water Quality Control Board.

As part of the Grass Valley Creek Gravel Enhancement Project, NRCS assisted RCD staff in choosing 4 sites to place spawning gravel in Grass Valley Creek. A monitoring protocol to track the gravel's movement in the creek was submitted to Fish and Game at the end of April. The 2-year project has a budget of about \$15,000. This gravel enhancement project is being funded by California Fish & Game.

5.20 Fuels Reduction Projects

RCD fuels crews are temporarily laid off until the first or second week of June. We should have the archeological portion of NEPA done so we may proceed with landowner contacts for the Poker Bar Project. NEPA should be completed soon so that we may begin to make landowner contacts for the South Fork Road Fuels Reduction Project and the Bear Creek Road/Rush Creek Estates Project.

5.25 Weaver Basin Wetlands

The kiosk/sign for the wetlands is being worked on by Erick Flikwir and is near completion. Jessica Oliver, one of our Watershed Stewards Members has been conducting weekly bird counts at the wetland and Lona Davis, a new Earth Team Volunteer with NRCS, is setting up vegetation monitoring.

5.30 Revegetation Coordinator's Report – Bernadette Cooney

Partnerships

U.S.F.S. - This fall the Forest Service Botanist, Susan Erwin, will oversee the removal of spotted knapweed, and at the RCD will follow up with the planting of grass plugs. The following year active carbon will be spread along with planting of additional plugs. This test project is designed to determine whether active carbon facilitates native plant establishment in an area previously occupied by knapweed. This project is being funded by the RAC for \$13,850.

Agricultural Commissioner- a pilot test trail using the non-synthetic herbicide consisting of acetic acid and citric acid was implemented at the airport to determine the efficacy of this treatment in controlling yellow starthistle. Soil samples were taken before and after the application to measure the change in pH.

Monitoring

Monitoring of the species composition and location of the riparian propagules planted at Hocker Flat using a GPS unit has been completed.

<u>Greenhouse</u>

The native grass plugs and Douglas-fir seedlings growing in the greenhouse have been relocated to the nursery. Several native species have been transplanted into larger containers and placed in the greenhouse in order to enhance their growth rate. A new product consisting of a strain of *Bacillus* controlled the spread of powdery mildew upon red fescue, but did not kill the fungus. This product is being tested upon the fungus, black spot that has infested the madrone seedlings.

<u>Nursery</u>

The enormous task of re-arranging the nursery so that like sized containers are together has been completed! It will facilitate the production of quality plant stock by having the ability to regulate optimum irrigation schedules. The next task will be to remove the weeds from the more juvenile plants.

Hayfork Community Day School

Taught the class the different parts of a flower and explained the difference between angiosperms and gymnosperms, as well as, monecious and diecious plants. The class went out into the field to identify the different flower parts. This is part of a semester-long program with these students being coordinated by Nancy Small, one of our Watershed Steward members.

Proposals 1 4 1

The RAC proposal Cynthia wrote to plant stream channel crossings on older projects in the South Fork has been re-formatted into a Fish and Game proposal due May 19th.

5.35 PEIR

The Board of Forestry will be the CEQA lead agency. A new Notice of Preparation (NOP) has been filed and advertised to seek public comments. A team meeting was held in Redding on May 4th. Kelly Sheen attended on behalf of the District.

5.40 Project Coordinator's Report – Cynthia Tarwater

South Fork of the Trinity River

- Cynthia Tarwater gave a presentation at Humboldt State University in Arcata for Career Day in early April. The power point presentation was for the HSU Geography Department and the topic was South Fork Trinity River Restoration.
- Cynthia Tarwater gave a presentation at Hayfork Community Day School class in early April. The field trip was to Kingsbury Gulch Road to review road inventory techniques and methods.
- Four RAC South Fork 2006-07 RAC Proposals totaling \$203,000 were approved in April, these included two decommissions in Hidden Valley (1N11C and 1N24B), one decommission in the Sims Fire area (4N13A) and one road upgrade (1N11). \$58,000 of these dollars are to be spent in 2006, the rest is for 2007 implementation.
- Preparing Requests for Proposals (RFP's) to California Department of Fish and Game, State Water Resources Control Board and the State OHV Commission.
- Contract development for this summer's projects began in late April; we will have 2-3 Formal Bids this year and will try to have them line up for award at the monthly Board meetings.

 The District met with BLM in April and laid out a strategy to begin to address road-related sediment problems in the Trinity River watershed. Dan Westermeyer is preparing grant applications for California Department of Fish & Game to address some high risk, high priority roads and will follow this up with projects to be included in the application to the State Water Resources Control Board.

5.50 Grant Coordinator's Report – Noreen Doyas

Preparing proposals to submit to California Department of Fish and Game, which are due May 19th.

The full proposal for the State Water Resources Control Board 319 (h) for Trinity River Watershed TMDL Implementation (\$675,000) is due June 9th. Pat attended a workshop on this program on April 21st in Sacramento.

Prepared a final report for the Watershed Coordinator project for the TRRP (Account #137).

Completed the full proposals for the California Fire Safe Council for Down River Communities Fuel Reduction Project (\$55,000) and Oregon Mt/Grass Valley Creek Watershed Fuels Reduction Project (\$95,000).

Completed the Work Plan for the EPA's Targeted Watershed Project in partnership with Trinity County and the Yurok.

5.60 GIS Specialist – Kelly Sheen

5.10 Grass Valley Creek--John Condon

The Lowden Field Wetlands Enhancement Project is proceeding without any major problems. We have received a nationwide permit from the Army Corps of Engineers. DWR staff contacted the Division of Water Rights (SWRCB) to confirm that a water right does exist at the state property where Lowden Field Wetlands will be constructed this spring. We have now submitted a 401-certification application to the North Coast Regional Water Quality Control Board. We will be constructing the small earthen berm and flashboard riser while equipment is on site during the dredging of the Hamilton Ponds.

Winter flows in Grass Valley Creek carried enough sediment to fill up the upper pond at the Hamilton Ponds Facility. In the week of June 19th, Graham Mathews and Associates will be working with RCD crews in performing a bathymetric survey of both ponds to determine volumes of sediment. We anticipate the engineers cost estimate to dredge the ponds will put the contract in the informal bid category (less than \$125,000). Work will be put out to bid in August, awarded in mid-September and dredging occurring soon thereafter.

NRCS and RCD staff met with an archaeologist and a botanist employed by the Humboldt Foundation in Arcata on June 13 to review site conditions at the Grass Valley Creek Gravel Supplementation Project. They were hired by CA Department of Fish and Game to locate and protect any endangered plants or significant archeological sites within the project area. They found nothing of significance. We are hoping to begin the project this fall when flows are at a minimum.

5.15 Weaverville Community Forest

Crews have been clearing brush on several old roads that will be reopened and on new roads that will be constructed for the logging that will occur this summer in the Community Forest. Material will be chipped and broadcast or utilized as firewood that will be donated to various causes.

Logs generated from the logging of hazard trees along TCPUD and PG&E rights-of-way.will have been delivered to the Trinity River Mill on June 16th. Two local loggers were used (Gary Jurin and Bob Jennings) due to limited access and equipment size required. Costs to move the logs and revenues generated from the logs are unknown at this time, but will be known by the board meeting.

5.20 Fuels Reduction Projects

We are hoping to bring back the entire RCD fuels crews the first week of July to begin implementting 5 of the fuels reduction projects this year. We should have the archeological portion of NEPA done by the end of the month so we may proceed with landowner contacts for the Poker Bar, Bear Creek Road/Rush Creek Estates and South Fork Road Fuels Reduction Projects. Projects in the Downriver Communities and at Oddfellows Camp and Oregon Street still need signed agreements in place and CEQA to be completed.

5.25 Weaver Basin Wetlands

The kiosk/sign for the wetlands is being worked on by Erick Flikwir and is near completion. Jessica Oliver, one of our Watershed Stewards Members has been conducting weekly bird counts at the

wetland. Bernadette is meeting with County staff on June 16th to look at planting success and a list of potential tasks with the remaining funds in our agreements with the County.

5.30 Revegetation Coordinator's Report – Bernadette Cooney

GIS Data Entry

The species composition and location of the riparian propagules planted at Hocker Flat using a GPS unit has been entered into ArcView and is currently being formatted for presentation to the TRRP.

Training

Accompanied NRCS staff to Eureka to attend, a two-day ArcGIS training session. The instructors were very knowledgeable and patient allowing me to gain a good understanding of the software's' capacity and how to perform the basic functions.

Survival Monitoring

Survival count of the riparian and upland species planted at Grub Gulch will be conducted next week.

Revegetation Site Assessments

Salt Flat Revegetation Site survival is very good; theflowers along the railings are spectacular! Bucktail Bridge Site is submerged under two feet of water. The riparian area of Hocker Flat is presently being scoured under several feet of water; the upland portion is growing vigorously.

Nursery

The conifer stock at the nursery has been inoculated with ectomycorrhizae to increase drought resistance. The ectomycorrhizae are fungi that attach to the fine roots of the conifers that aid in the absorption of water and nutrients. A technician is being sought so that time can be taken off in order to allow for adequate funding for revegetation in the fall.

5.35 PEIR

The Board of Forestry is the CEQA lead agency. The team continues to work on the draft document and conduct literature research on emerging issues. Kelly Sheen is our key contact on behalf of the District.

5.40 Project Coordinator's Report – Cynthia Tarwater

South Fork of the Trinity River

- Much of the first of May involved assisting the Grants Coordinator with the Requests for Proposals (RFP's) to California Department of Fish and Game which were due by the 19th. Four Proposals totaling \$443,000 were submitted relating to the South Fork of the Trinity Watershed including three road decommissions (Lake Mtn. area of Hyampom, the Upper South Fork and a private road in Potato Creek) and one Revegetation project to plant riparian species in excavated stream channels.
- An Informal request for bids for a decommissioning project in Smoky Creek involving the 29N11 and the 29N75B roads was sent to contractors on the 2006 TCRCD Contractors list and was advertised in the Trinity Journal on May 31 and again on June 7, 2006. The mandatory walk-through of the project is on June 9 and the project will be implemented between July 10 and August 31 of this year. The award of contract to the lowest responsible bidder is scheduled for the June 21st Board Meeting.

- Planning and contract development continues for other projects that will go out to bid for this summer.
- The Wild and Scenic South Fork of the Trinity River, being the longest un-dammed river in the state of California, has ranked high with all grantors and the District has been awarded \$1.4 million for 2006 to 2010 for continued restoration efforts. Since 1997 the district has been awarded \$4 million for the South Fork.

5.50 Grant Coordinator's Report – Noreen Doyas

Submitted 7 proposals to California Department of Fish and Game, including Potato & East Fork Hayfork Creek Road Decommission (\$64,920), High School Salmon & Riparian Education Project (\$18,462), Upper South Fork Road Decommission (\$129,633), Monroe & Big Slide Creek Road Decommission (\$225,000), South Fork Trinity River Riparian Restoration (\$27,049), Conrad Gulch Road Decommission (\$25,000), and Weaverville Community Forest Road Upgrade (\$37,107).

Submitted the full proposal for the State Water Resources Control Board 319 (h) for Trinity River Watershed TMDL Implementation (\$675,000).

5.60 GIS Specialist – Kelly Sheen

In May, the GIS/IT department allocated time to the following projects:

- GIS development, cartographic layout, and map production to support Baldwin, Blomstrom, and Wilkinson Associates (BBWA) on Phase I of planned Fuel Treatments in the Weaverville Community Forest. These efforts are part of the District's Trinity County Watershed Coordinator project – BOR (39 hours - Acct. #: 137).
- Formatting, layout, content editing, and website content creation for the Spring 2006 *Conservation Almanac*, Volume 15, Number 2 as a part of the Trinity River Restoration Program Public Education and Outreach project – BOR (37 hours - Acct. #: 120).
- Data coordination and meeting with USFS officials to layout the scope of work in preparation to begin creating a GIS spatial database for all the past and current RAC projects that have been funded in Trinity County to date USFS (17.5 hours Acct. #: 163).
- GIS development, cartographic layout, and map production for the Hidden Valley Road Decommissioning project USFS (16 hours Acct. #: 140).
- GIS development, cartographic layout, and map production for the Dumpsite Clean-up project – TCWM (12 hours - Acct. #: 144).

- GIS development, data coordination, and meeting attendance with BBWA and CDF officials for the statewide Programmatic Environmental Impact Report project – CDF (11.5 hours -Acct. #: 142).
- Other miscellaneous Computer Systems/Network Administration tasks, including regular maintenance of District computers, staff and supervisor's meetings, and general website updates (35.5 hours Acct. #: 01).

5.70 Safety Officer's Report

On-Line Safety Training

The District is now participating in an on-line safety training program that is provided by SDRMA, our workers compensation carrier. In addition to providing employee safety training that is required by CalOsha, these courses have been proven to help reduce safety risks and increase safety awareness which in turn reduces worksite injuries and incident claims. To introduce employees to the program, a computer was set up and an on-line training demonstration was given at the May staff meeting. Employees can access the training program at work or from home to complete the courses as their time permits.

Through the program, we currently have 60 courses related to work place safety and accident prevention to choose from with another 60 available soon. Each course takes about 15 to 30 minutes to complete and focuses on safety issues such as:

Back Injury Prevention Driving Safety Office Safety Alcohol Free Workplace Combustible & Flammable Liquids Fall Protection

Our current goal is to supplement our "tailgate" safety meetings by having each employee complete one course per month on District time. To help get the program off and running, the District Manager is offering a \$50 gift certificate to "On Your Feet" that will be raffled off in July at a safety luncheon. Each employee participating in the program, who completes a course in May and June, will have a raffle ticket entered in the drawing for each class successfully completed.

In addition to the benefits of the required training at no additional cost, the District can receive an education credit incentive from SDRMA of up to 4% off of our workers compensation insurance rate, if 25% of the District's employees complete four courses each year. At our current annual rate of approximately \$150,000, this can mean a savings of \$6,000.

Trauma Kits

In response to requests from the field crews, the field trucks now have a complete "trauma safety kit" that is designed to address more serious trauma issues that crews may encounter while working with chain saws or around heavy equipment, in addition to the basic first aid kits. These kits are stored in ammo cans and are to be accessed in emergency situations only and must be inventoried and restocked any time the seal is found broken.

5.75 Other Projects/Issues

NRCS and RCD personnel met with a landowner at the Eagle Creek Ranch to look at an EQIP project involving fuels reduction/forest health. About 3 years ago RCD crews performed similar work on the ranch on a fee for service basis. The budget for the project is approximately \$18,000.

RCD fuels crews worked clearing a TCPUD right of way near Wyntoon Resort. Trees and shrubs were cut and chipped to allow equipment to access the area so another line can be installed. PUD forester, Dave DeLange, mentioned that more work similar to this will be put out to competitive bid later this summer.

Crews will be back working on Phase 3 of the Farm and Ranch Solid Waste Cleanup and Abatement Grant Program on June 15. Work will include the areas of Burnt Ranch, Salyer, Denny, Big Bar, Big Flat, Lewiston, Douglas City and Weaverville.

After a year and a half of tinkering, the RCD's water trailer is nearly complete. The 10' long trailer consists of a 330 gallon capacity water tank, 200' of 3/4"rubber fire hose and reel, 600' of 1" cloth fire hose and a 13 HP fire pump. We are hoping to rent this piece of equipment to local contractors/loggers working in the woods who are required to have fire suppression equipment on the job site. We are also going to be using the trailer on RCD projects that include; fuels reduction where pile burning is required, water for irrigation needed and in road construction. Components to help build the trailer were donated by BLM, US Forest Service and CDF.

DWR staff contacted the Division of Water Rights (SWRCB) to confirm that a water right does exist at the state property where Lowden Field Wetlands will be constructed this spring. We should be receiving our 401-certification letter from the North Coast Regional Water Quality Control Board within the next few days. BLM biologist Gary Diordoni is preparing a Categorical Exclusion NEPA document. We will be constructing the small earthen berm and flashboard riser while equipment is on-site during the dredging of the Hamilton Ponds.

Winter flows in Grass Valley Creek carried enough sediment to fill up the upper pond at the Hamilton Ponds Facility. In the week of June 19th, Graham Mathews and Associates worked with RCD crews in performing a bathymetric survey of both ponds to determine volumes of sediment. It was determined that about 12,500 cubic yards are in the upper pond (approximately). We anticipate the engineers cost estimate to dredge the ponds will put the contract in the informal bid category (less than \$125,000). Work will be put out to bid in August, awarded in mid-September and dredging occurring soon thereafter.

A BLM biologist continues to work on the NEPA for the Grass Valley Creek Fish Passage Enhancement Project. The project involves installing 4 baffles in the culvert and constructing several rock weirs below an 8-foot shot-gunned culvert located on Little Grass Valley Creek at the Oddfellows Camp. We are hoping to perform the work in September.

5.15 Weaverville Community Forest

Crews have been chipping brush and trees on several old roads that will be reopened and on new roads that will be constructed for the logging that will occur this summer in the Community Forest.

We have completed moving the powerline right-of-way logs to the local mill. Two self-loaders and a small dozer were hired at a total cost of \$4,221. The dozer was utilized for a day to skid trees to a landing for transport as well as rebuild an access to an old haul road that will be used this summer. Over 30 loads of logs were moved to the Trinity River Mill. We are still summarizing the information, but have received our first payment from the mill.

Survival Monitoring

Survival rate of the 2-0 Ponderosa pine was 59% at Grub Gulch.

<u>Nursery</u>

Provided training on nursery management to Lona Davis our nursery technician (intern). Lona will be overseeing the maintenance of the nursery during the remainder of the summer.

Weaver Basin Wetlands

Manual weed control has been on going. The aesthetic appearance of the site has been greatly enhanced by the cutting down of the white sweet clover (*Melilotus alba*) a non-native herbaceous herb. This herb can grow 7 ft. in height, obscuring the view of many of the native grasses and shrubs.

EQIP

Drafted a letter explaining the EQIP program and the RCD's ability to facilitate planting to reduce sediment erosion to the residents affected by the Lowden and Oregon Fires.

5.40 Project Coordinator's Report – Cynthia Tarwater

South Fork of the Trinity River

- An Informal request for bids for a decommissioning project in Smoky Creek involving the 29N11 and the 29N75B roads was sent to contractors on the 2006 TCRCD Contractors list and was advertised in the Trinity Journal on May 31 and again on June 7, 2006. The mandatory walk-through of the project was held on June 9 and we had 3 contractors attend the walk-through and two submitting bids. The contract was awarded to John Buick Construction, in the amount of \$39,280, at the June 21st Board Meeting.
- Planning, contract development and advertisements for 2 other large projects (Klondike and Sulphur Glade) that will be considered for award at the July 19 Board Meeting.
- Met on June 27 with California Department of Fish and Game officials to look at proposed grant applications submitted earlier this year for restoration projects in the South Fork.
- Prepared a draft Final Report to the State Water Resources Control Board for our Clean Water Act 319(h) grant. They will review the draft and then we will finalize it.

5.75 Other Projects/Issues

RCD crews continue to work at the Eagle Creek Ranch on a project involving fuels reduction/forest health. About 3 years ago RCD crews performed similar work on the ranch on a fee for service basis. The budget for the project is approximately \$18,000.

Crews will be back working on Phase 3 of the Farm and Ranch Solid Waste Cleanup and Abatement Grant Program in early August. Work will include the areas of Burnt Ranch, Salyer, Denny, Big Bar, Big Flat, Lewiston, Douglas City and Weaverville. We also will close out the earlier phases.

RCD signed a fee for services agreement with a local contractor to chip material that was cut underneath the PG&E powerline right-of-way from Oregon Street to just east of Junction City. Only

material within 50 ft. of a road or driveway will be chipped. The project should keep a crew of 2 busy for a couple of weeks.

A RCD crew of 2 performed a fee for service chipping project a property near Salyer on Fountain Ranch Road.

When flows on the Trinity River come down to 450 cfs later this summer, we are going to be installing several gabion baskets at the Rush Creek and Bagdad boat launches to improve boaters access to the river. NEPA needs to be completed for both sites. The project is funded under a task order with BLM.

BLM engineering contacted the RCD to put together a cost estimate to repair storm-damaged roads in the Junction City and Douglas City areas. The BLM obtained these funds from their state office in Sacramento to repair damage to BLM roads within the boundaries of the Redding Field Office from the storms this past winter.

5.10 Grass Valley Creek--John Condon

The Lowden Field Wetlands Enhancement Project is proceeding without any major problems. We have received a nationwide permit from the Army Corps of Engineers. DWR staff contacted the Division of Water Rights (SWRCB) to confirm that a water right does exist at the state property where Lowden Field Wetlands will be constructed this spring. We have received our 401-certification letter from the North Coast Regional Water Quality Control Board. BLM biologist Gary Diordoni is preparing a Categorical Exclusion NEPA document. We will be constructing the small earthen berm and flashboard riser while equipment is on-site during the dredging of the Hamilton Ponds.

Winter flows in Grass Valley Creek carried enough sediment to fill up the upper pond at the Hamilton Ponds Facility. In the week of June 19th, Graham Mathews and Associates worked with RCD crews in performing a bathymetric survey of both ponds to determine volumes of sediment. It was determined that about 12,500 cubic yards are in the upper pond (approximately). We anticipate the engineers cost estimate to dredge the ponds will put the contract in the informal bid category (less than \$125,000). Work will be put out to bid in August, awarded in mid-September and dredging occurring soon thereafter.

A BLM biologist continues to work on the NEPA for the Grass Valley Creek Fish Passage Enhancement Project. The project involves installing 4 baffles in the culvert and constructing several rock weirs below an 8-foot shot-gunned culvert located on Little Grass Valley Creek at the Oddfellows Camp. We are hoping to perform the work in September.

5.15 Weaverville Community Forest

Crews have been chipping brush and trees on several old roads that will be reopened and on new roads that will be constructed for the logging that will occur this summer in the Community Forest.

We located more trees on the PG&E powerline that have been taken to the Trinity River Mill by Bob Jennings at a cost of \$1,670. We are waiting for scale ticket receipts from the mill to see how much revenue was generated by the sale of the logs. The financial manager should have available at the board meeting the total receipts generated by the sale of the P.G.&E. R.O.W. logging.

5.20 Fuels Reduction Projects

We are hoping to staff-up the RCD fuels crews the third week of August to begin implementing 5 of the fuels reduction projects this year. We have begun to make site visits to several landowners in the Bear Creek and Rush Creek. The archeological/historical resources survey is complete for the Poker Bar Project. The preliminary report is that there are no sites within the project area. A final report is expected before the end of the month. Projects in the Downriver Communities and at Oddfellows Camp and Oregon Street still need signed agreements in place and CEQA to be completed.

After observing the path and behavior of the Junction Fire that burned over 3,000 acres west of Weaverville the weekend of July 30 & 31, it appears that the regional shaded fuels break on Oregon Mtn Ridge constructed by RCD crews a few years ago slowed the spread of the fire. Discussions with several landowners in the area mentioned that CDF fire crews explained to them that the fire would have not been able to be held at the ridge if it weren't for the fuels break. A total of 8 homes were

immediately saved by the regional fuels break and by the defensible space clearing of fuels around these homes and outbuildings. The one structure that did burn as a result of the fire did not participate in the program. The fire did "spot" over the ridge Saturday night and into the western portion Community Forest but was put out quickly by fire crews burning less than an acre. The area was located beneath the TCPUD power line and had heavy ground fuels build up as it was recently cut by contract crews as part of the TCPUD ROW clearing.

RCD staff met with new USFS Downriver Fuels Officer Paul Johnson on July 24th to review the RCD work around portions of Salyer Heights subdivision. About 22 acres were not completed due to budget constraints on the project. Additional funds were secured by the USFS to complete the unfinished work by RCD crews before September 30, 2006.

5.25 Weaver Basin Wetlands

The kiosk/sign for the wetlands that was being worked on by Erik Flikwir was installed on August 7th. A sord of mallards was observed swimming in the middle pond the week of August 7th. Some weed maintenance has occurred and watering of last winter's plantings, but the severe summer weather has taken its toll on these seedlings.

5.30 PEIR

The Board of Forestry is the CEQA lead agency. The team continues to work on the draft document and conduct literature research on emerging issues. Kelly Sheen is our key contact on behalf of the District. BBWA is working closely with CDF staff. Frost participated in a conference call for the team to prepare for a meeting with two (2) members of the Board of Forestry.

5.40 Project Coordinator's Report – Cynthia Tarwater

South Fork of the Trinity River

- On July 7th there a mandatory walk-through of two large projects in the South Fork of the Trinity River; the decommissioning on the 1S01 road just a few miles west of Forest Glen and the very end of the Miller Springs Road (1N24) out by Sulphur Glade Ridge. We had the same two contractors show for both walk-through and bid on the 1N24 road, only one bid was submitted for the 1S01. Both contractors have worked for the District for many years and are qualified for this work. At the July Board meeting the 1S01 was awarded to the only bidder, Deneau Company, for \$76,580 and the 1N24 project was awarded to the lowest bidder, John Buick Construction for \$171,102. The 1S01 road decommissioning came in under cost and so we will be able to add a small trail along the upper bank. Both of these projects are to be completed this year, we may be able to construct a small trail on the other project, at this time I'm not sure, but will try.
- On July 11th, work started by on the 1N24C road out by Sulphur Glade Ridge and is nearly finished. This project is by Force account and Hale Equipment and Deneau Company are working this project.
- On July 17th, I showed 3 projects that we submitted to Fish and Game to the contract administrators, this is the first step in qualifying for funding. One project is near Hyampom in the Monroe Creek drainage, another is a collection of roads in the Upper South Fork and lastly a small revegetation project on our older decommissions. We will find out next spring if we will receive funding.

- On July 20th, the Smoky Road Decommissioning started which was awarded at the June Board meeting to John Buick Construction, this project involves two roads (29N11 and the 29N75B), the 29N11 road is nearing completion and then they will move to the other road.
- On July 26th, I attended a tour of a Forest Service RAC Project on the 29N62C road and then attended the Bob Reiss Mad River Fuel Break Dedication Ceremony as a District representative later that afternoon.

When flows on the Trinity River come down to 450 cfs later this summer, we are going to be installing several gabion baskets at the Rush Creek and Bagdad boat launches to improve boaters access to the river. NEPA needs to be completed for both sites. The project is funded under a task order with BLM.

BLM engineering contacted the RCD to put together a cost estimate to repair storm-damaged roads in the Junction City and Douglas City areas. The BLM obtained these funds from their state office in Sacramento to repair damage to BLM roads within the boundaries of the Redding Field Office from the storms this past winter.

Dan Westermeyer has started implementing the remainder of the Butter Creek Road decommissioning project. This RAC-funded project was started last year and it should be completed later in August.

NRCS and the District are helping with the formation of a Trinity River Watershed CRMP. Two "formation" meetings have been held and a third one is planned for August 10th. While working on the formation, the core team also is hoping to get on-the-ground in the Lewiston area to assess the Lowden fire and implement some remedial projects to reduce sediment delivery to the river.

Rourke explained the purpose of this information-only presentation. The Board requested that Mark Lockhart provide this educational presentation to help the Board better understand issues surrounding pesticides and their application as it relates to the District's policies.

Lockhart introduced himself and provided a handout titled California Restricted Material. He described the history of Agriculture Commissioners in California and their role in regulating pesticide uses. He described the history and current status of federal and state laws regarding pesticides. The Federal Insecticide, Fungicide, Rodenticide Act (FIFRA) is the federal law and it is implemented by the US EPA. There are NEPA and CEQA evaluations for agencies engaged in "activities". State regulations can and, in the case of California, are more restrictive than federal regulations and the County Ag. Commissioner has the authority to be even more restrictive, if there is a local need for such. He also described the Private Applicator Certificate Exam and approval process and the process involved in the application of restricted materials using his handout. The Board and members of the public asked questions, which Lockhart answered. J. Allen, representing Trinity County Planning Department's Natural Resources Division, provided handouts describing the history of herbicide policies adopted by the County dating back to 1979.

4.0 For Information Only – Presentation on Establishing an Endowment Fund by Alexandra Reid Humboldt Area Foundation

5.10 Grass Valley Creek--John Condon

The Lowden Field Wetlands Enhancement Project is proceeding without any major problems. We have received a nationwide permit from the Army Corps of Engineers. DWR staff contacted the Division of Water Rights (SWRCB) to confirm that a water right does exist at the state property where Lowden Field Wetlands will be constructed this spring. We have received our 401-certification letter from the North Coast Regional Water Quality Control Board. BLM biologist Gary Diordoni is preparing a Categorical Exclusion NEPA document. We will be constructing the small earthen berm and flashboard riser while equipment is on-site during the dredging of the Hamilton Ponds.

On Friday September 8th the RCD held a walkthrough for contractors interested in dredging the Hamilton Ponds. The engineers estimate to perform the work is \$60,000. Approximately 13,000 cubic yards will be dredged for the two ponds. Based on the results of the bid opening on September 15th, work will commence on September 25 and should take about 2.5 to 3 weeks to complete the project.

A BLM biologist continues to work on the NEPA for the Grass Valley Creek Fish Passage Enhancement Project. The project involves installing 4 baffles in the culvert and constructing several rock weirs below an 8-foot, shot-gunned culvert located on Little Grass Valley Creek at the Oddfellows Camp. We are hoping to perform the work in September.

The Grass Valley Creek Gravel Supplementation Project is ready to implement. Fish and Game and RCD met in the field on September 7 to discuss the logistics of gravel placement. Nearly 300 cubic yards of 1"-6" spawning gravel will be placed at several locations on Grass Valley Creek over a two year period.

5.15 Weaverville Community Forest

Three roads have been opened and gated in the Community Forest as part of the Phase I fuels reduction timber sale. One road will remain permanent while the other two will be partially or totally decommissioned after logging is complete next summer. We will be meeting with several loggers, who are interested in the project, within the next couple of weeks. We would like to start sometime and October and finish the sale next summer. AmeriCorps members, Jessie Oliver and Nancy Small have volunteered to help set up photo-monitoring stations associated with the plots established by BBWA in 2004.

5.20 Fuels Reduction Projects

We are hoping to staff-up the RCD fuels crews the third week of September to begin implementing 5 of the fuels reduction projects this year. We have begun to make site visits to several landowners in the Bear Creek and Rush Creek. The archeological/historical resources survey is complete for the Poker Bar Project. The preliminary report is that there are no significant sites within the project area. A final report is expected any day. Projects in the Downriver Communities and at Oddfellows Camp and Oregon Street still need signed agreements in place and CEQA to be completed.

RCD crews have returned to the Salyer Heights subdivision to finish about 22 acres that were not completed due to budget constraints. Additional funds were secured by the USFS to complete the work by RCD crews before September 30, 2006.

5.25 Weaver Basin Wetlands

Some watering has occurred of last winter's plantings, but the severe summer weather has taken its toll on these seedlings. We plan on performing more planting this fall and continue irrigating into the summer months. We heard that NRCS Earth Team volunteer Lona Davis arranged to have four green herons released at the wetlands last month that were being cared for by Shasta Wildlife Rescue.

5.30 PEIR

The Board of Forestry is the CEQA lead agency. The team continues to work on the draft document and conduct literature research on emerging issues. Kelly Sheen is our key contact on behalf of the District. BBWA is working closely with CDF staff.

5.40 Project Coordinator's Report – Cynthia Tarwater

South Fork of the Trinity River

Both the Smoky Creek Road Decommissioning and the 1N24C Road Decommissioning project were completed by August 10. Smoky was funded by California Dept. of Fish and Game and California OHMV and the 1N24C project was funded by California Dept. of Fish and Game and the Trinity County RAC.

Slightly off subject for the South Fork; however, we supervised a small EQIP project in Weaverville the week of August 14. This project involved one small stream channel realignment, a culvert upgrade at a stream crossing and various road drainage improvements, including rock surfacing. This project is funded by NRCS EQIP and private landowner contributions.

About August 18, mobilization began for the Sulphur Glade Road Decommissioning Project. There has been a change in scope for this project that reduced the project size by 2/3. The project will now be limited to the 1N24.02 road alone this year. This project is funded by the Trinity County RAC

On August 21, mobilization began for a small road decommissioning project in the Sims Fire area near Hyampom, this project is funded by the USFS.

Our last project for the summer, the Klondike Project (1S01), will begin the beginning of September.

5.50 Grant Coordinator's Report – Noreen Doyas

Submitted a proposal to the Trinity River Restoration Program for continuing our Education and Outreach Project for \$96,641 for a four-year period.

Submitted a proposal to the Sierra-Cascade Regional Nutrition Network to continue the Weaverville Summer Day Camp Nutritional Enhancement Project for \$4,990.

Considering a proposal for the Wildland Urban Interface grant program for fuels reduction implementation and education. Requires a 50% non-federal match, a difficult requirement for the District. Due September 11.

5.60 GIS Specialist – Kelly Sheen

In August, the GIS/IT department allocated time to the following projects:

- GIS development and data coordination to support the sediment source analysis component of the Rush Creek Watershed Analysis, and satisfying specific GIS requests made by BOR staff. - GIS development, cartographic layout, and map production in support of the proposed extension of the Weaverville Community Forest (WCF) on US Forest Service lands – TC (28.5 hours - Acct. #: 169).
- Formatting, layout, content editing, and website content creation for the Summer 2006 *Conservation Almanac*, Volume 15, Number 3 as a part of the Trinity River Restoration Program Public Education and Outreach project BOR (26.75 hours Acct. #: 120).
- GIS development, data acquisition, and meetings with organizations that have received Title II RAC funding. The meetings and data coordination have been essential in the creation of a spatial database of all the past and current RAC projects that have been awarded in Trinity County USFS (11.5 hours Acct. #: 163).
- GIS development, data coordination, and cartographic layout as a part of the "Big Red Truck" project RAC (9 hours Acct. #: 46).
- Development of a project checklist for tracking landowner participation and work completed for the Bear Creek/Rush Creek, Lower South Fork Road, and Poker Bar fuels reduction projects FSC (5 hours Acct. #: 152, 153, 165).
- GIS development, cartographic layout, and map production to support Baldwin, Blomstrom, and Wilkinson Associates (BBWA) on Phase I of planned Fuel Treatments in the Weaverville Community Forest (WCF). Assisted with accounting for initial log sales from WCF – BLM (4 hours - Acct. #: 166).
- Formatting, layout design, content editing, and printing fliers and posters for the 2006 Salmon Festival as a part of the Environmental Education project EPA (1 hour Acct. #: 156).
- Other miscellaneous Computer Systems/Network Administration tasks, including the setup of the District's new network server and backup system, regular maintenance of District computers and network, staff and supervisor's meetings, and general website updates (57 hours Acct. #: 01).

5.70 Safety Officer's Report – Dan Westermeyer

We will provide safety reports on a quarterly basis, or "as needed" when there are important items/issues.

5.75 Other Projects/Issues

RCD crews continue to work at the Eagle Creek Ranch on a project involving fuels reduction/forest health. About 3 years ago RCD crews performed similar work on the ranch on a fee for service basis. The budget for the project is approximately \$18,000.

Crews will be back working on Phase 3 of the Farm and Ranch Solid Waste Cleanup and Abatement Grant Program in September. Work will include the areas of Burnt Ranch, Salyer, Denny, Big Bar, Big Flat, Lewiston, Douglas City and Weaverville. We also will close out the earlier phases.

RCD crews have cleared brush below a TCPUD power line near the Trinity Alps Resort on our ongoing agreement with PUD. The work took a crew of 3 about 2 days to complete the 1,200' of brushing.

A RCD crew of 2 performed a fee for service fuels reduction project in the Timber Ridge subdivision for Jim Woodward.

When flows on the Trinity River come down to 450 cfs later this summer, we are going to be installing several gabion baskets at the Rush Creek and Bagdad boat launches to improve boaters access to the river. NEPA needs to be completed for both sites. The project is funded under a task order with BLM.

BLM engineering contacted the RCD to repair storm-damaged roads in the Junction City and Douglas City areas. The BLM obtained these funds (+/- \$50K) from their state office in Sacramento to repair damage to BLM roads within the boundaries of the Redding Field Office from the storms this past winter. We plan on repairing roads at Valdor Gulch, Union Hill Road and County Line Road South before winter rains this season.

Dan Westermeyer has started implementing the remainder of the Butter Creek Road decommissioning project. This RAC-funded project was started last year and it should be completed later in August.

NRCS and the District are helping with the formation of a Trinity River Watershed CRMP. Three meetings have been held. The next one is scheduled for the last week in September. While working on the formation, the core team also is hoping to get on-the-ground in the Lewiston area to assess the Lowden fire and implement some remedial projects to reduce sediment delivery to the river, especially at a sediment basin along Old Lewiston Road that is full.

The RCD donated 10 gabion baskets to the Weaverville Sewer District, who will be using them to protect a sewer line that has been exposed due to an eroding stream bank. RCD and NRCS provided technical advice in their installation. The baskets were donated to the RCD by BLM a few years ago when they were cleaning out surplus material from their bone yard in Redding.

5.10 Grass Valley Creek--John Condon

The Lowden Field Wetlands Enhancement Project will be implemented soon after the dredging of the Hamilton Ponds. The NEPA document from BLM will be finalized by the time of the October Board meeting.

The diversion channel was opened up around the upper pond at the Hamilton Ponds facility on October 6. Dredging of both ponds will begin on Tuesday October 10. We anticipate the project to be completed in 5 days. Approximately 12,000 cubic yards will be removed from both ponds.

After discussing the Little Grass Valley Fish Passage Enhancement project with BLM biologist, we have decided to put the project off yet another year to discuss the feasibility of installing a bridge instead. Conversations with BLM staff in Eureka have led us to the possibility of funds being available to help with the bridge installation. The funded project involves installing 4 baffles in the culvert and constructing several rock weirs below an 8-foot, shot-gunned culvert located on Little Grass Valley Creek at the Oddfellows Camp

The Grass Valley Creek Gravel Supplementation Project will be implemented on the week of October 9. Fish and Game and RCD met in the field on September 7 to discuss the logistics of gravel placement. Nearly 300 cubic yards of 1"-6" spawning gravel will be placed at several locations on Grass Valley Creek over a two year period.

5.15 Weaverville Community Forest

No bids were received from the 2 loggers who attended a walk-through on September 29. A recommendation on where to go from here with the project will be presented by the Project Manager at tonight's board meeting.

5.20 Fuels Reduction Projects

We are hoping to staff-up the RCD fuels crews in October by 1 and to begin to implement several fuels reduction projects this year. We have begun to make site visits to several landowners on Bear Creek and Rush Creek Road. Letters were sent to landowners in the Lower South Fork Road and Poker Bar Fuels Reduction Projects. Responses to the letters from both locations have been fairly light so far. With scheduled visits in mid-October, projects in the Downriver Communities and at Oddfellows Camp and Oregon Street still need signed agreements in place and CEQA to be completed.

RCD crews continue to work on USFS lands near Salver Heights subdivision. This needs to be completed before the winter rains as the USFS plans to burn the piles this winter.

5.25 Weaver Basin Wetlands

Some watering has occurred of last winter's plantings, but the severe summer weather has taken its toll on these seedlings. We plan on performing more planting this fall and continue irrigating into the fall. Jessie Oliver, WSP AmeriCorps member, is re-starting the bird monitoring and will begin taking staff gauge readings, too. Her successors with WSP will continue to conduct this monitoring.

5.30 PEIR

The team continues to work on the draft document and conduct literature research on emerging issues. Work has centered around setting up a treatment alternatives hierarchy with the CDF GIS staff. Kelly Sheen is our key contact on behalf of the District. BBWA is working closely with CDF staff. The Board of Forestry is the CEQA lead agency and this has resulted in some delays in the projected schedule. The District has asked about a time extension and will also begin negotiating budget adjustments to deal with any changes in the scope of work.

5.40 Project Coordinator's Report – Cynthia Tarwater

South Fork of the Trinity River

The Sulphur Glade Road Decommissioning Project (1N24.01 and .02), which was reduced in scope due to contract compliance issues, was completed on September 14. We completed the 1N24.02 road this year and the remainder will be advertised next spring for implementation next summer. This project is funded by the Trinity County RAC and supplemented by California Dept. of Fish and Game.

A small road decommissioning project in the Sims Fire area near Hyampom was completed mid-September. This project has been extended with additional funding from the USFS. The work next year must benefit the fire area and should be confined to road decommissioning projects.

Our last equipment project for the summer in the South Fork, the Klondike Road Decommissioning Project (1S01), will be completed by October 15. This project is funded by California Department of Fish and Game and the EPA.

Lastly, we have the Swift Creek Project (1S11) a road decommissioning project currently advertised with a scheduled mandatory walk-through on Friday, October 13, 2006 at 10 AM. Bids will be received for an award at the November board meeting with the project implemented next summer. We hope to increase our pool of competitive bidders by advertising this year for next year's work....We'll see if it works! This project is funded by California Department of Fish and Game and the EPA.

5.50 Grant Coordinator's Report – Noreen Doyas

The State Water Resource Control Board approved our Consolidated Grants application for the Trinity River TMDL Implementation for \$675,000. This proposal addresses sediment issues throughout the watershed, including the South Fork and tributaries in the upper reaches of the mainstem below the dam. The State Board's goal is to have contracts signed by the end of the calendar year.

The TRRP approved our proposal for Public Information and Outreach for Trinity River Restoration Program for \$96,641 for a period of four years (through 9/30/10).

The California Fire Safe Council informed us that our proposal for the Trinity County Fire Safe Council Planning & Outreach for \$24,955 will be funded by BLM. This proposal fell below the funding line earlier, but additional funds have become available.

The California Regional Nutrition Network informed us that they approved our grant application for the Weaverville Summer Day Camp Nutritional Enhancement Project for \$4,790.

Obtained an additional \$20,000 from the USFS for Sims Roads (in the South Fork Trinity River Watershed).

Submitted a proposal for the Wildland Urban Interface grant program for the Trinity County Community Chipper Program for \$56,350. Requires a 50% non-federal match. We heard from CDF that this proposal ranked first in the region. We submitted a proposal to the North Coast Air Quality Management District for \$25,000 of the matching funds.

Updated the Pending Project List (see attached)

Sent letters along with entry permits and a map of the project area to the landowners in Poker Bar (98 letters) and Lower South Fork Road (40 letters) regarding the upcoming fuels reduction projects for those communities.

Considering applying for the Klamath River Restoration Grant Program for over \$500,000 of state funds for the Trinity River Restoration Program to increase rearing habitat for anadromous salmonids in areas of highest intensity natural spawning in the Trinity River by modifying channel banks and floodplains, constructing side channels, incorporating large woody debris, and revegetating floodplains and channel margins. Applying for this grant is a task that the TRRP wants the District to do through their Watershed Coordinator grant. A concern is that the District would have to take on the role of CEQA lead agency as Trinity County does not want to assume that liability.

5.60 GIS Specialist – Kelly Sheen

In September, the GIS/IT department allocated time to the following projects:

- Formatting, layout design, content editing, and printing fliers and posters for the 2006 Salmon Festival. Data analysis of non-resident landowners in Trinity County to estimate to cost of expanding the distribution of the *Conservation Almanac*. Both these tasks are a part of the Trinity River Restoration Program Public Education and Outreach project – BOR (16 hours -Acct. #: 120).
- GIS development, cartographic layout, and map production to support the District's stewardship effort in the Weaverville Community Forest (WCF) (13 hours Acct. #: 101).
- GIS development, data acquisition, and meetings with organizations that have received Title II RAC funding. The meetings and data coordination have been essential in the creation of a spatial database of all the past and current RAC projects that have been awarded in Trinity County USFS (12 hours Acct. #: 163).
- GIS development, data coordination, and cartographic layout as a part of the "Big Red Truck" project RAC (9 hours Acct. #: 46).
- Design work of several draft logos for the new Northwestern RC&D administrative district as a part of the CARCD-RC&D support project NRCS (5.5 hours Acct. #: 108).
- GIS development for the Bear Creek/Rush Creek, Lower South Fork Road, and Poker Bar fuels reduction projects FSC (5 hours Acct. #: 152, 153, 165).
- Initial document preparation for USDA eAuthentication allowing District employee access to secure NRCS data network as a part of the Northern California NRCS GIS Support project – RAC (4.5 hours - Acct. #: ?).

- GIS development in support of the Salyer/Hawkins Bar fuels reduction project USFS (2 hours Acct. #: 125).
- GIS development, layout, and map production as a part of the EPA Road Decommissioning project Yurok (2 hours Acct. #: 164).
- Review of proposed GIS data model to be used in the statewide Programmatic Environmental Impact Report project CDF (1.5 hours Acct. #: 142).
- Other miscellaneous Computer Systems/Network Administration tasks, including the setup of the District's new network server and backup system, regular maintenance of District computers and network, staff and supervisor's meetings, and general website postings and updates (67 hours Acct. #: 01).

Over the summer, our website saw a slowdown in the number of visitors who spent time on our pages. 5.70 Safety Officer's Report

The on-line safety training program provided by the District's workers' compensation carrier has been working out well. Over the last three months, 12 employees have completed 31 safety modules that cover 13 different subjects. The modules include a wide range of topics such as Back Injury Prevention, Driving Safety, Eye Safety and Office Safety. Every employee is asked to complete one safety module each month on District time, but can complete as many additional modules as they like on their own. Employee participation in the training program helps reduce the District's workers compensation cost and the risk of on-the-job injuries.

In recognition of completing nine months of the safety program and an accident-free work place, the District recently sponsored a celebratory barbecue at the Lowden Park cook shack for employees and families. A \$50 gift certificate to On Your Feet was raffled to participants in the on-line safety training program and was won by Zack Blanchard. Extra roasts and chickens cooked by Mike Rourke and family were also raffled off at the end of the evening. A best dessert contest was also held and won by Jessica Oliver though every dessert could have been considered a winner the way they disappeared. As an incentive to reach a one year accident free workplace, Pat Frost announced that talks were in the works with the Trinity Theater owner to provide a private screening of a first run movie for District employees and families.

5.75 Other Projects/Issues

RCD crews continue to work at Eagle Creek Ranch on a project involving fuels reduction/forest health. About 3 years ago RCD crews performed similar work on the ranch on a fee for service basis. The budget for the current project is approximately \$18,000, funded by landowners.

Crews will be back working on Phase 3 of the Farm and Ranch Solid Waste Cleanup and Abatement Grant Program in October. Work will include areas of Burnt Ranch, Salyer, Denny, Big Bar, Big Flat, Lewiston, Douglas City and Weaverville. We also will close out the earlier phases.

When flows on the Trinity River come down to 450 cfs later this summer, we are going to be installing several gabion baskets at the Rush Creek and Bagdad boat launches to improve boaters' access to the river. NEPA has been completed for both sites. The project is funded under a task order with BLM.

BLM engineering contacted the RCD to repair storm-damaged roads in the Junction City and Douglas City areas. The BLM obtained funds (+/- \$50K) from their state office in Sacramento to repair damage to BLM roads within the boundaries of the Redding Field Office from the storms this past winter. We plan on repairing roads at Valdor Gulch, Union Hill Road and County Line Road South before winter rains this season. All the projects will be completed in October.

The Butter Creek Road Decommissioning Project (roads 2N34B and 2N37) near the Indian Valley Guard Station has been completed and is awaiting final inspection from the U.S.F.S. Additional drainage maintenance work was also done on the 2N22 road. This RAC-funded project started late last year but was halted due to wet weather conditions. Dan Westermeyer has taken the lead on the Dark Gulch sediment basin maintenance project in Lewiston off of Old Lewiston Road. The TRRP is providing emergency funding (\$30,000) for this project, which will remove an estimated 3,000 to 4,000 cubic yards of sediment that was captured in this sediment basin, designed by NRCS and built with EWP funds after the Lowden Fire. The deposition of sediment was the result of a landslide during the 2005/2006 winter rains.

NRCS and the District are helping with the formation of a Trinity River Watershed CRMP. Three meetings have been held. The next one is scheduled for October 12.

To help assist in numerous revegetation projects this fall and winter, the RCD has hired Earth Team volunteer Christy Wagner on a part-time, as needed basis. This January, Christy will be part of the AmeriCorps program here in Weaverville for the next year.

We'd also like to welcome Mark Dowdle, our new Education Coordinator/Office Assistant and Russ Spangler, our October AmeriCorps member.

5.10 Grass Valley Creek--John Condon

The dredging of the Hamilton Ponds was completed on October 27. A total of approximately 9,200 cubic yards of material was excavated from the upper and lower ponds by Jurin Construction out of Willow Creek.

Gravel has been placed in Grass Valley Creek at several locations as part of the Grass Valley Creek Supplementation program.

The Lowden Field Wetlands Project is near completion. The 4-foot high dam and the flashboard riser were installed on November 7. Representatives from BLM, DWR, BOR, NRCS and RCD met on November 9 to discuss a planting plan utilizing BOR funds. When winter rains commence we will install the wooden flashboards and monitor water levels in the wetlands.

5.15 Weaverville Community Forest

Since no bids were submitted for the logging of the Weaverville Community Forest the District is pursuing other options. The contracting procedures manual, "Cost Accounting Policies and Procedures Manual of the California Uniform Public Construction Cost Accounting Commission," Section 22038: "Rejection of Bids, Failure to Receive Bids; Options," paragraph (c), states, "If no bids are received through the formal or informal procedure, the project may be performed by the employees of the public agency by force account, or negotiated contract without further complying with this article." We will be meeting with Stan Leach of French Gulch within the next few weeks to discuss a negotiated price to perform the logging next summer.

All roads in the Community Forest have been winter-proofed.

5.20 Fuels Reduction Projects

RCD crews continue to work on the Salyer Heights project on USFS lands using RAC funding. We are hoping to finish the project within the next few weeks.

Projects are ready to be implemented in the Bear Creek and Rush Creek area as well as the Poker Bar area. We are hoping to start work in the Bear Creek and Rush Creek areas first.

The fuels reduction project for the Lower South Fork Road has gotten little response from landowners, so staff is looking at additional outreach.

5.25 Weaver Basin Wetlands

Our Watershed Stewards members (AmeriCorps) have started to monitor water levels in the wetlands for this winter. Bird surveys will be conducted, also.

5.30 PEIR

Based on a recent teleconference with the project team, the District and CDF will be modifying the agreement. It will be extended and there likely will be additional funding. These amendments are

needed because of the shift in Lead Agency status from CDF to the Board of Forestry. The goal still is to have an administrative draft by April 1, 2007

5.40 Project Coordinator's Report – Cynthia Tarwater

South Fork of the Trinity River

Our last equipment project for the summer in the South Fork, the Klondike Road Decommissioning Project (1S01), was completed on October 12. This project was funded by California Department of Fish and Game and the EPA. Currently all work in the South Fork has wrapped up for the season.

Five interested contractors attended the mandatory walk-through of the Swift Creek Road Decommissioning Project (1S11) on October 13, 2006 and three contractors submitted bids by 5 pm on October 25. This project will be awarded at the November board meeting and implemented next summer. This project is funded by California Department of Fish and Game and the EPA.

On October 16 we began the repair of Valdor Road on BLM land, which washed out last December. This project, unrelated to South Fork, was funded by the BLM and involved unplugging the culvert at Wheel Gulch, constructing a critical dip to eliminate diversion potential in the future and filling the gaping hole in the road with approximately 400 cubic yards of various rock types and soil. This project was completed by October 24.

5.50 Project Implementation Coordinator Report -- Dan Westermeyer

Butter Creek Road Decommissioning

The Butter Creek Road Decommissioning project was completed mid August. This was a RAC funded project near the Indian Valley Guard Station that included the decommission of two roads, one 1.0 mile long and the other 1.7 miles long, as well as maintenance work on the 2N22 road and the placement of rip rap material in a roadside ditch that was experiencing severe down cutting on the 2N10 road. The local contractor was Mike Hall from Weaverville.

Dark Gulch Basin Excavation

The Dark Gulch excavation project in Lewiston was completed with \$30,000 emergency funding from the Bureau of Reclamation through the Trinity River Restoration Program. During the winter storm of 2005-2006, a debris flow that originated in the 1999 Lewiston fire burn area filled a culvert inlet basin with approximately 8,000 cubic yards of sediment and overflowed onto Lewiston Road. The county expressed concerns they would not have adequate funding or permit approval in time to complete the project prior to the onset of winter. The District was able to restore a portion of the inlet basin that was constructed in 1999 with NRCS Emergency Watershed Protection funds by excavating 2,500 cubic yards of material, and reopening the culvert (buried under 12 ft of sediment) and overflow culvert inlets. The local contractor used for the project was Frank Zabel and several independent truckers. Approximately 2,000 cubic yards of material were stockpiled on BLM property at Bucktail where it will be used next year by the TRRP as topsoil when they complete their Dark Gulch Channel Rehabilitation Project. Approximately 500 cubic yards of material were disposed of on private property along the trucking route per landowner request. This project was completed with the assistance of funding from TRRP, permit assistance and project review from the county Road Department and NRCS, and NEPA review and Categorical Exclusion designation by the Bureau of Land Management.

Klamath Basin Conference

The District served as the leader for the Trinity River Sub-basin at the Klamath Basin Conference held in Redding on November 7-9. The task included organizing an interactive poster session, which focused on restoration efforts and alternative resource uses within the basin. Participants representing the Trinity River at the session included the TRRP, the Five County Coho Program, the Watershed Research and Training Center, Trinity River Land Trust, NRCS, and the District. This event, which focused on the status of the Klamath River Basin and current restoration efforts, was attended by 250 people from the north state and Oregon areas.

5.60 Grant Coordinator's Report – Noreen Doyas

Our proposal for the Wildland Urban Interface grant program for the Trinity County Community Chipper Program for \$56,350 was approved for funding. This grant requires a 50% non-federal match. Our proposal to the North Coast Air Quality Management District for \$25,000 of the matching funds is pending.

Submitted an application to the Klamath River Restoration Grant Program for \$575,000 for the Trinity River Restoration Program for the Lewiston 4 and Dark Gulch Channel Rehabilitation Project. This project will increase rearing habitat for anadromous salmonids in areas of highest intensity natural spawning in the Trinity River by modifying channel banks and floodplains, constructing side channels, incorporating large woody debris, and revegetating floodplains and channel margins.

Attended the Watershed Workgroup meeting at the TRRP Office on October 23. The District may be requested to administer the \$330,000 that was approved by the TMC for what has been called the Trinity County Grants program to fund local high priority projects. It was suggested that the District submit a proposal to undertake road inventory on private lands (particularly in the Lewiston Fire area), but not to limit it to that, in order to help prioritize potential projects that will reduce sediment to the Trinity River.

Planning on submitting a pre-proposal to CDF's Urban Forestry Grant Program to help with education and outreach and demonstration projects for the Weaverville Community Forest. This is due December 8.

5.70 GIS Manager's Report – Kelly Sheen

In October, the GIS/IT department allocated time to the following projects:

- GIS development, data acquisition, and meetings with organizations that have received Title II RAC funding. The meetings and data coordination have been essential in the creation of a spatial database of all the past and current RAC projects that have been awarded in Trinity County USFS (22.5 hours Acct. #: 163).
- GIS development, cartographic layout, and map production to support the District's stewardship effort in the Weaverville Community Forest (WCF) (17 hours Acct. #: 101).
- Development of a monitoring form to track landowner participation for the Bear Creek/Rush Creek, Lower South Fork Road, and Poker Bar fuels reduction projects – FSC (16 hours -Acct. #: 152, 153, 165).
- GIS development, cartographic layout, and map production in support of various District presentations given at the CARCD Annual Conference. These efforts are part of the District's Trinity County Watershed Coordinator project BOR (8 hours Acct. #: 137).

- Document preparation for USDA eAuthentication allowing District employee access to secure NRCS data network as a part of the Northern California NRCS GIS Support project – RAC (5 hours - Acct. #: 180).
- Cartographic layout and map production to assist in monitoring the survival of plantings at the Hocker Flat restoration sites as a part of the Bridge Site Preparation, Maintenance, and Restoration project BOR (4 hour Acct. #: 116).
- Provided mobile technology support to the Project Manager in support of the Smoky Creek Hydroclosure project DFG (3.5 hours Acct. #: 174).
- Design work of several draft logos for the new Northwestern RC&D administrative district as a part of the CARCD-RC&D support project NRCS (2 hours Acct. #: 108).
- Other miscellaneous Computer Systems/Network Administration tasks, including the setup of the District's new network server and backup system, regular maintenance of District computers and network, staff and supervisor's meetings, and general website postings and updates (84 hours Acct. #: 01).

5.70 Safety Officer's Report - None at this time. The next quarterly report will be provided in December.

5.75 Other Projects/Issues

The Timber Bridge Project is going well. Almost all of the materials to construct the bridge have been purchased. A volunteer day will occur on November 18 to begin site preparation and construction of the bridge. BLM has donated 8 concrete piers that will be used for the bridge footings. SPI has allowed the RCD and volunteers to construct the bridge on a landing about 100' from the placement site. The bridge will be skidded down the road to a staging area using the two skidder bridges built using funds from another RC&D grant. Final placement of the bridge will be done by cable, blocks and backhoe.

A fee for service project in Hyampom involving the installation of a drip irrigation system and planting will be completed by November 17. The project was funded in part by the NRCS CRP program.

A fee for service project involving forest stand improvement and fuels reduction at Eagle Creek Loop Ranch was completed November 2. Total cost of the project was \$18,000.

Project Implementation Coordinator Report for November 2006

Butter Creek Road Decommissioning

The Butter Creek Road Decommissioning project was completed mid August. This was a RAC funded project near the Indian Valley Guard Station that included the decommission of two roads, one 1.0 mile long and the other 1.7 miles long, as well as maintenance work on the 2N22 road and the placement of rip rap material in a roadside ditch that was experiencing severe down cutting on the 2N10 road. The local contractor was Mike Hall from Weaverville.

Dark Gulch Basin Excavation

The Dark Gulch excavation project in Lewiston was completed with \$30,000 emergency funding from the Bureau of Reclamation through the Trinity River Restoration Program. During the winter storm of 2005-2006, a debris flow that originated in the 1999 Lewiston fire burn area filled a culvert inlet basin with approximately 8,000 cubic yards of sediment and overflowed onto Lewiston Road. The county expressed concerns they would not have adequate funding or permit approval in time to complete the project prior to the onset of winter. The District was able to restore a portion of the inlet basin that was constructed in 1999 with NRCS Emergency Watershed Protection funds by excavating 2,500 cubic yards of material, and reopening the culvert (buried under 12 ft of sediment) and overflow culvert inlets. The local contractor used for the project was Frank Zabel and several independent truckers. Approximately 2,000 cubic yards of material were stockpiled on BLM property at Bucktail where it will be used next year by the TRRP as topsoil when they complete their Dark Gulch Channel Rehabilitation Project. Approximately 500 cubic yards of material were disposed of on private property along the trucking route per landowner request. This project was completed with the assistance of funding from TRRP, permit assistance and project review from the county Road Department and NRCS, and NEPA review and Categorical Exclusion designation by the Bureau of Land Management.

Klamath Basin Conference

The District served as the leader for the Trinity River Subbasin at the Klamath Basin Conference held in Redding on November 7th-9thth. The task included organizing an interactive poster session, which focused on restoration efforts and alternative resource uses within the basin. Participants representing the Trinity River at the session included the TRRP, the Five County Coho Program, the Watershed Research and Training Center, Trinity River Land Trust, NRCS, and the District. This event, which focused on the status of the Klamath River Basin and current restoration efforts, was attended by 250 people from the north state and Oregon areas.

5.10 Grass Valley Creek--John Condon

Gravel placed in Grass Valley Creek at several locations as part of the Grass Valley Creek Supplementation program will be monitored throughout the winter months for transport downstream as well as for fish utilization.

The Lowden Field Wetlands Project has been completed with the installation of the flashboards. Water levels will be monitored this winter to determine planting locations next spring.

5.15 Weaverville Community Forest

We will be meeting with Stan Leach of French Gulch within the next few weeks to discuss a negotiated price to perform the logging next summer. District staff and members of the community had the opportunity to meet with Gerry Gray, from American Forests in Washington D.C. on December 7. Mr. Gray is a Vice President of this policy organization and was asked to visit the community forest by the BLM National Forester. BLM is hoping to increase exposure of the Weaverville Community Forest at the national policy level through the help of American Forests.

5.20 Trinity River Restoration Program

RCD crews have been collecting nearly 5700 cuttings (willows and cottonwoods) that will be planted at four restoration sites on the Trinity River that are known as the Canyon Creek Suite of sites.. The BOR will hire a local contactor (excavator and stinger attachment) to install the cuttings with RCD crews. We plan on doing the project beginning the week of December 26.

5.25 Fuels Reduction Projects

RCD crews have stopped work on the Salyer Heights project on USFS lands that used RAC funding, due to exhausting all monies. USFS Fuels Technician Paul Johnson was very satisfied with the work our crews did. An article promoting the project was in the local Willow Creek newspaper, Bigfoot Valley News.

Work has begun on several lots in the Poker Bar Subdivision. We have obtained permission from about 30 landowners to perform fuels reduction on their property associated with a California Fire Safe Council grant.

Crews will begin to work on the Bear Creek portion of the Rush /Bear Ck. project as conditions allow. Kenneth Baldwin and RCD folks will meet with 3 landowners to discuss a logging prescription as part of the fuels reduction treatment that should generate in-kind revenues for the project under the PTEIR.

The fuels reduction project for the Lower South Fork Road has gotten little response from landowners, so staff is looking at additional outreach. Crew leader Mike Dunlap's wife grew up in the area, so we will try to use that connection to improve contact there.

Staff had the opportunity to spend a day with our grant manager from the California Fire Safe Council last week. Amber Gardner came to Weaverville to conduct a grant-writing workshop (See Grant Coordinator Report) and stayed for a tour of projects on December 5.

5.30 Weaver Basin Wetlands

We will be meeting this winter with Trinity County to discuss a planting plan for the wetlands using funds obtained from CalTrans as mitigation for the Rocky Point Passing Lane Project.

Our Watershed Stewards (AmeriCorps) members have started to monitor water levels in the wetlands for this winter. Bird surveys will also be conducted. NRCS may have some additional WRP money. NRCS and the District are looking at options for these funds.

5.35 PEIR

The District and CDF are modifying the cooperative agreement. It will be extended for one year and \$33,000.00 in additional funding has been included in the revision. These amendments are needed because of the shift in Lead Agency status from CDF to the Board of Forestry. The goal is to have a draft available for public review by April 1, 2007 and a Final document submitted to CDF by October 1, 2007 for presentation to the Board of Forestry.

5.40 Project Coordinator's Report – Cynthia Tarwater

South Fork of the Trinity River

At the November 15 TCRCD Board Meeting, the Swift Creek Road Decommissioning Project was awarded to Deneau Company in the amount of \$126,000. This project will begin next summer.

The final report to USFS South Fork Management Unit summarizing the work accomplished on the forest this year was completed in late November. We addressed approximately 10 miles of roads during 2006. Treatment varied from road upgrading to decommissioning. Approximately \$380,000 was spent between July and October 2006 with \$243,000 of that amount expended strictly on equipment costs. This is consistent with our past pattern of a 65/35 split between equipment costs and overall District costs (including administration). Presently, the South Fork has \$1.4 million secured for the next few years. Planning for implementation will begin now and continue for the next few months and we will start putting together RFP packages for next spring. I will continue to coordinate work in the South Fork from a temporary work station in Florida for the next few months. Please don't hesitate to contact me there if you have any questions.

I want to thank Pat Frost, John Condon, the Board, and *everyone* at the TCRCD for all the support they've provided recently, and of course over the past 13+ years. I will be in touch.

5.50 Project Implementation Coordinator Report -- Dan Westermeyer

Dan attended a three-day Streambank Soil Bioengineering workshop sponsored by Yolo County RCD and presented by NRCS. The workshop focused on the latest techniques for use of native vegetative material such as willow, alder and cottonwood to stabilize eroding stream banks and riparian areas undergoing undesirable erosion. It addressed problems experienced by landowners with small or ephemeral creeks, so these techniques are applicable to much of the work performed by the District.

The District worked with the County and other agencies to provide a collaborative presentation to the TAMWG group on non-Trinity River Restoration Program (TRRP) projects within the Trinity River Watershed on December 12. The District's presentation focused on leveraging funds received from the TRRP for watershed coordination to use as matching funds to obtain additional grants for work in the Trinity watershed. Russ Spangler, our newest AmeriCorps member, created an effective PowerPoint presentation for the meeting.

Progress is being made in formation of the Trinity River Watershed Council, which is being spearheaded by the District through the Watershed Coordinator grant from TRRP. The Watershed Council will be similar to the South Fork CRMP that the District was involved with in the past, and will focus on tributary issues along mainstem Trinity River. The main function of the Council will be to review, prioritize and assist with implementation of projects that address water quality and fisheries issues.

5.60 Grant Coordinator's Report – Noreen Doyas

Submitted a pre-proposal to CDF's Urban Forestry Grant Program in the amount of \$\$226,000 to help with Master Plan development, education and outreach, and material utilization demonstration projects for the Weaverville Community Forest, Lee Fong Park and Lowden Park.

Submitted two proposals to the Board of Supervisors for Title III: \$10,000 for Weaverville Community Forest Stewardship; \$5,000 for Weaverville Summer Day Camp.

Attended the McConnell Foundation Workshop on November 29. A total of \$50,000 will be available to Trinity County with grant applications due March 7, 2007.

Attended the California Fire Safe Council's Grants Clearinghouse Workshop on December 4. The next round of Fire Safe Council grants are due on-line February 15, 2007.

Completed the necessary forms to finalize the 319(h) grant with the State Water Resources Control Board for \$675,000 for the Trinity River Watershed TMDL Implementation Project.

5.70 GIS Manager's Report – Kelly Sheen

In November, the GIS/IT department allocated time to the following projects:

- Formatting, layout, content editing, and website content creation for the Fall 2006 *Conservation Almanac*, Volume 15, Number 4 as a part of the Trinity River Restoration Program Public Education and Outreach project BOR (42.5 hours Acct. #: 120).
- Prepared for the South Fork Project Manager's new remote support role by researching and upgrading a notebook computer, installing requested software and hardware, and performing data backup and transferal from PM's desktop. These efforts were completed as a part of the EPA Swift Creek & Various Decoms project Yurok (35 hours Acct. #: 164).
- Finalized USDA eAuthentication allowing the District's GIS Manager access to the secure NRCS data network. Attended planning meetings with Western Shasta RCD staff and NRCS project supervisors. Began initial steps of data collection and analysis. These efforts are part of the Northern California NRCS GIS Support project RAC (27 hours Acct. #: 180).
- GIS development, cartographic layout, and map and banner production in support of various District presentations given at the Klamath Watershed Conference. These efforts are part of the District's Trinity County Watershed Coordinator project BOR (16 hours Acct. #: 137).
- GIS development, cartographic layout, data acquisition, and coordination with organizations that have received Title II RAC funding. These efforts are part of the Trinity County RAC GIS project USFS (9.5 hours Acct. #: 163).

- Cartographic layout and map production to assist in monitoring the survival of plantings at the Hocker Flat restoration sites as a part of the Bridge Site Preparation, Maintenance, and Restoration project – BOR (9 hours - Acct. #: 116).
- GIS development, cartographic layout, and map production to support the District's stewardship effort in the Weaverville Community Forest (WCF) (3 hours Acct. #: 101).
- Other miscellaneous Computer Systems/Network Administration tasks, including the setup of the District's new GIS laptop, regular updates and maintenance of District computers and network, staff and supervisor's meetings, and general website postings and updates (40.5 hours Acct. #: 01).

5.80 Other Projects/Issues

The Timber Bridge Project is going well. A volunteer day on November 18 to begin site preparation, transport materials and construction of the bridge went well. Approximately 20 people showed up, including one with a small excavator. The mob was split into two groups, one to work on the bridge, the other to build a new trail in the area. Lunch was provided by Scott Morris of the Weaverville Basin Trail Committee. A group of skilled carpenters from the Gonpa were hired to complete the bridge by December 31.

At the request of the Regional Water Quality Control Board in Santa Rosa, John visited a newly constructed road to several parcels adjacent to Reading Creek. The concern from Water Quality was the proximity of the new road to the creek and delivery of sediment. As a short term "emergency fix," a total of 8 rolling dips were installed to break up concentrated flows. An over-side drain (donated by the District) was installed where the road intercepts a small Class 3 stream. The landowner may be cited by Water Quality for not having an approved erosion control plan in place before ground disturbance occurred. Such a plan must be prepared by a licensed engineer or geologist. This scenario continually occurs and is another example of why Trinity County needs a grading ordinance.

RCD met with CalTrans to discuss changes to the Rocky Point planting project. The original plan called for several planters to be constructed within the spoils pile. The planters were to be filled to a depth of 4-5 feet with topsoil to allow larger trees (5-15 gallon container) to be planted in them. The larger trees would have had a more immediate impact on the aesthetics of the barren areas. Due to various reasons the planters were not constructed. Instead, we are going to plant pine, fir and cedars on 20-ft spacing throughout the entire spoils area and possibly irrigated. We are hoping that by irrigating the trees they will have a better chance of surviving in the 12-24 inches of topsoil covering the larger spoil rocks generated from the excavation. CalTrans also mentioned interest in purchasing hundreds of conifers from us to replace trees in their project on Oregon Mountain that burned in the recent Rifle Fire.

We are hoping to install gabion baskets at the Bagdad boat launch before high river flows inundate the access points. The installation would improve boat trailers launching access.

Crews should be completing a CRP riparian enhancement project in the Hyampom area by the end of the week of December 11. The project is an NRCS cost-share program with the landowner.

Crews should be starting work in January on dumpsite cleanups funded by Waste Management Grants.

We are beginning to liquidate planting stock at the RCD nursery. We have established reasonable prices for sale of plants and will be informing local government entities and the public about

availability. Four landowners recently purchased native grass seed from our inventory to stabilize potentially erosive soils.

Project Implementation Coordinator Report- December

Dan attended a three-day Streambank Soil Bioengineering workshop sponsored by Yolo County RCD and presented by NRCS. The workshop focused on the latest techniques for use of native vegetative material such as willow, alder and cottonwood to stabilize eroding stream banks and riparian areas undergoing undesirable erosion. It addressed problems experienced by landowners with small or ephemeral creeks so is applicable to much of the work performed by the District.

The Vehicle Policy and monthly vehicle maintenance form were updated to reflect current conditions at the District and to meet requirements of Cal-OSHA and address other safety concerns. After review and adoption by the Board, the policy will become part of the District's Injury and Illness Prevention Plan (IIPP), which will be presented for review and approval by the Board in January. The IIPP is required by Cal-OSHA to reduce job-related accidents and injuries. Once adopted, the IIPP should reduce the District's worker's compensation insurance rates as well.

The District worked with the County and other agencies to provide a collaborative presentation to the TAMWG group on non-TRRP projects within the Trinity River Watershed on December 12. The District's presentation focused on leveraging funds received from the TRRP for watershed coordination to use as matching funds to obtain additional grants for work in the Trinity watershed. Russ Spangler, our newest Americorps member, created an effective PowerPoint presentation for the meeting.

Progress is being made in formation of the Trinity River Watershed Council which is being spearheaded by the District through the Watershed Coordinator grant. The Watershed Council will be similar to the South Fork CRMP the District was involved with in the past, and will focus on tributary issues along mainstem Trinity River. The main function of the Council will be to review, prioritize and assist with implementation of projects that address water quality and fisheries issues.
