- **1.0 Call to Order:** The meeting was called to order at 5:36 PM by M. Rourke.
- 2.0 Discuss/Take Action on Approval of Agenda

MSC – K. Collard/J. Ritz to approve the Agenda.

The motion passed unanimously.

- 3.0 Discuss and Approve Meeting Minutes
  - 3.1 Discuss and Approve Minutes of the February 28, 2024 Meeting

MSC – K. Collard/M. Grigsby to approve the Minutes of the February 28, 2024 Meeting.

The motion passed unanimously.

#### 4.0 Financial Reports

- 4.1 Discuss Updated January Monthly Financial Report
- J. Caldwell reported that January is still in the negative for \$16,000 for the month. However, there is more invoicing to do. CAL FIRE is done through February.



- 4.2 Discuss February Monthly Financial Report
- J. Caldwell reported that CalTrans invoices still need to be done. Also, the crews are almost all back to work, minus Botany and the new Forestry Techs.
- 4.3 Discuss/Approve List of Warrants for February 2024
- M. Grigsby questioned the Costco purchases. J. Caldwell explained the situation with our new Costco Citi Card, the loss of our debit card, and the anticipated use of a Chase Business card. We do have a CalCard, but the limit is only \$10K and there are no benefits to using it.

MSC: M. Grigsby/J. Ritz to approve the February 2024 warrants in the amount of \$217,594.34.

The motion passed unanimously.

### 5.0 Projects Reports

Discussion was held about the Odd Fellows' Camp road problems. C. Tarwater, Roads Manager, has been trying unsuccessfully to find funding but the TCRCD did donate some materials and labor for emergency work.

### 6.0 NCRS Report

C. Cole was not in attendance due to a family emergency.

### 7.0. Trinity Collaborative Report

K. Sheen reported that the Recreation subcommittee of the Collaborative met on March 8. There was an Open House regarding the Minersville Boat ramp, held in Trinity Center that was well-attended. Also new to the discussion was an announcement that the owners of Cedar Stock will not be opening the marina in Trinity Center this season. The Forest Service will be meeting with them to discuss that.

The full Collaborative also met, on March 15. More discussion was held regarding the Wildfire Alert cameras. T. Jones brought up a five-year plan for discussion. Lastly, the April field tour has not yet been scheduled.

8.0 Discuss/Take Action on the Notice of Exemption Under Statutory Exemption Class 4, Section 15304, Minor Alterations to Land (Trinity Knolls Fuels Reduction Project)



Brief discussion took place about the project, which will be for the Trinity Center VFD. M. Grigsby moved that the Board adopt the staff recommendation on the Notice of Exemption. J. Ritz seconded the motion.

The motion passed unanimously.

### 9.0 Discuss/Take Action on the Notice of Exemption Under Statutory Exemption Class 4, Section 15304, Minor Alterations to Land (Middle Trinity Fuels Reduction Phase I, Lewiston Area)

Discussion took place about the project. K. Sheen described that the fuels treatment will be similar to Browns Mountain. M. Rourke noted it would be nice to have before and after photos, using a drone, to show the community.

M. Grigsby moved that the Board adopt the staff recommendation on the Notice of Exemption. J. Ritz seconded the motion.

The motion passed unanimously.

### 10.0 Discuss/Take Action on Voting for CARCD Board Officers

K. Collard shared that he had attended the Zoom meeting, which ended up without a quorum; no vote was taken. A discussion of the candidates took place. After discussion, K. Collard moved that the TCRCD board vote for Peter Braudrick and Harold Singer. M. Grigsby seconded the motion.

The motion passed unanimously.

### 11.0 Board Reports/Correspondence

### 12.0 District Manager's Report

K. Sheen reported the following:

- Regarding the question raised at the last meeting about Fish and Wildlife removing brown brook trout: this has been confirmed; the intent is to remove them from 70 different lakes throughout the Trinity Alps, where they have decimated amphibians and invertebrates.
   Brook trout are non-native to the lakes in the area.
- TCRCD board meeting notices now appear on the Journal's government calendar listing.
- The Botany department had two candidates and will be making a job offer to one of them soon.



- The State Coastal Conservancy has a block grant opportunity in the amount of \$6 million. We are working on the proposal, in which several North Coast RCD's would participate. It is due April 1. It would provide excellent Match for federal projects.
- The RAC awards have been funded and letters are going out to applicants.
- We will likely receive more requests to be CEQA lead.
- The WRTC NFWF request was reduced.
- Sheen finished a financial plan for Collaborative Facilitation which will be in the approximate amount of \$136,000.

#### PROJECTS REPORT

April 17, 2024

### 5.1 Weaverville Community Forest –Bethany Llewellyn, Adriana Rodriguez

- Grizzlycorps fellow Liam Bassler and Project Coordinator Adriana Rodriguez carried out the second of three scheduled field trips for high school students on the Weaverville Community Forest on April 16<sup>th</sup>. This series is a partnership with the Nor Rel Muk Wintu Nation, Sierra Pacific Industries, and the United States Forest Service, and introduces students to careers in forest-related professions.
- The steering committee met on March 6<sup>th</sup>, with discussions including new signage in the Weaver Basin Trail System and a progress report on the Strategic Plan.
- The new Weaverville Community Forest sign was put up on Musser Hill and looks great!
- The BLM harvest on Oregon Mountain is progressing. Talks with a log buyer at Trinity Lumber began last month. We are still finalizing the details of the stewardship harvest process.
- There is still money left for BLM surveys in the WCF NEPA project. We are waiting for BLM to identify/prioritize their next WCF project for us to start utilizing those funds.
- Grizzlycorps Fellow Liam Bassler is working with Erik Flikwir on updating the WCF website.
- Trinity County Resource Advisory Committee: Our proposal for ongoing education and outreach on the Weaverville Community Forest was recommended for funding. These funds will support the continuation of the Forestry field trips, wildflower hike, and other programming.

### 5.2 <u>Watershed Coordination – Kayla Meyer, Annyssa Interrante</u>

• Both K. Meyer and A. Interrante are out of office. No report.

### 5.3 Project Coordinator's Report –Cynthia Tarwater

In early to mid-March we were conducting storm patrol and recon on several sites completed last year. There was too much snow at some, but eventually, we were able to get to a few for assessment. We monitored a small decommission that was completed last fall, Blue Rock Road, Roundy Road, Hobo Gulch Road, the Wild-Mad Road to look at snow level, and several others. We wrapped up our last slide cleanup near the Ruth Lake Dam until we can fix it later this year, the disposal site was seeded and mulched upon departure.

- We were asked to look at a slide blocking access in the Hall Gulch watershed on the 37N08Y road. This road is on the east side of Trinity Lake and has a large active slide above the road. We were able with equipment to de-water the area by reconstructing an inboard ditch to an existing ditch relief culvert and were able to fix the road even though at that time it was too wet for travel. We also cleared several plugged culverts in the area. We will reassess the slide area in a few weeks to see if travel across is advisable until we can do a complete repair later in the year. (See photo.)
- We also were able to take a look at Mainline Road in Grass Valley Creek, the road is in severe disrepair and we anticipate the BLM will provide funding for repair, but we haven't heard much to date. The road crew did some minor handwork that day where they could make a difference.
- Multiple staff and crew attended Red Card fire training in March and our first trip for erosion control materials was done in March to get us started on a productive year.

### 5.5 Botany & Revegetation Projects - Annie Barbeau & Kaety Howard

- RAC Native Plant Nursery: Nursery activities this month included more transplanting of winter-stratified seedlings. Species planted included Klamath plum, incense cedar, and mountain mahogany. Plants were fertilized with kelp, fish emulsion, and chelated iron to improve washed-out winter soils.
- RAC Noxious Weeds: No update this period.
- <u>Title III Community Wildfire Mitigation (Noxious Weeds):</u> No update this period.
- <u>Caltrans Hayfork Culverts II (PM 25.24)</u>: The Project Coordinator and Program Manager met onsite with the Caltrans Program Manager to discuss planting design and other implementation logistics. Discussion also occurred at the site of the Hayfork Mountain Culverts (PM 24.97) project that will be executed in April. Some of the designated plants for this project were maintained at the native plant nursery and will be planted this spring. Other needed species were purchased at Floral Native Nursery in Chico on March 27<sup>th</sup>. Approximately 60 trees and shrubs are slated for planting.

#### • Caltrans Swift Creek Bridge Replacement:

The Project Coordinator and Program Manager made a site visit in preparation for the initial planting this Spring. Planting areas were measured using GIS data collection tools on-site, and then a planting design was developed including a planting map depicting the project layout. A species palette was created, submitted, and approved by partners. Initial planting will begin on April 16 and will be completed by the end of the month. Time was spent maintaining nursery plants for the upcoming planting.

A volunteer planting event at this site is scheduled for Friday, May 3<sup>rd</sup>. Rotary member Pat Frost and Project Coordinator Kaety Howard are working together to coordinate a memorial planting honoring their members on this project site at the intersection of State Highway 3

- and Swift Creek Rd. Rotary will be donating funds to cover costs associated with the planting, as well as coordinating involvement with Trinity Center elementary school students.
- <u>Caltrans Ditch Gulch Curve Improvement:</u> Maintenance of the remaining nursery plants to be planted at the project site occurred. Planting will be completed this spring.
- <u>Caltrans Big French Creek Onsite Mitigation:</u> The designated plants for this project were maintained at the native plant nursery and will planted this spring. Planning for the field season continued.

### • Program Development:

- ♦ Two new Conservation Technicians were hired with a start date of April 8<sup>th</sup>. One other new conservation technician hired into the Forest Health Program will work with the Botany Program for two weeks before beginning work on the Forestry crew.
- ♦ The Program Manager and Project Coordinator attended the Trinity County Resource Advisory Committee (RAC) meeting to present project proposals. Two proposals were presented:
  - (1) Trinity County Priority Noxious Weed Management This project will support continued monitoring and treatment of species such as dyer's woad, diffuse knapweed, and Scotch broom in Northern Trinity County.
  - (2) TCRCD Native Plant Nursery This funding will help support the growth and maintenance of our native plant nursery to support our revegetation projects as well as sales to local natural resource agencies and the public.
  - (3) Both projects were approved for the following funding amounts:
    - (a) Trinity County Priority Noxious Weed Management: \$17,500.
    - (b) TCRCD Native Plant Nursery: \$15,000.
- ♦ The Program Manager and Project Coordinator attended a two-day NEPA training which provided beneficial knowledge as the District expands its capacity to lead third-party NEPA agreements.
- ♦ The Program Manager, Annie Barbeau, has been working with Roads Program Manager, Cynthia Tarwater, for preparation of conducting rare plant surveys required prior to road decommissioning within the USFS Pettijohn project area. Surveys will begin in April.
- ♦ The 2021 Ford F250 "8746" which was already taken to the Corning Ford Dealership in February to address the perceived shifting error, was driven with their transmission specialist technician and our project coordinator on March 27<sup>th</sup>. Due to the area not being mountainous in the Corning area, we were not able to reproduce the error at that time. The truck was left once again with Corning Ford with an agreement that the Ford technicians would drive the truck to Black Butte Lake to attempt to recreate the conditions that triggered the error. Follow-up is scheduled for April 4<sup>th</sup>.

### 5.6 <u>Fuels and Forestry Projects – Bethany Llewellyn, Dave Johnson, Adriana Rodriguez, Shay</u> Callahan

- Forest Health (FH) Staff News: Fuels crews are now fully staffed (16 people). One Forestry Crew (2 staff) has started and the other will begin April 22. We may increase Forestry Crew capacity over the summer by hiring 1-2 college interns.
- Management: 4 Crew: 18 Grizzlycorps: 1

- <u>Bureau of Land Management Lewiston Agreement/California Coastal Conservancy Lewiston</u>

  Resilience Phase II: We are waiting for the BLM to return to Lewiston to wrap up this project.
- Bureau of Land Management Weaverville Community Forest Stewardship: FH staff completed marking for the Oregon Mountain timber sale and began drafting harvest contracts. Staff met with a Log Buyer from Trinity Lumber on March 12<sup>th</sup>.
- Cal Fire Trinity County Hazardous Fuels Reduction Phase II Grant: Implementation has begun on burning ~145 acres of piles built last spring along the Browns Mountain ridgetop. In the final year of this project, implementation will take place in Coffee Creek, Trinity Center, and in other communities through the chipping program.
- Training and continuing education:
  - Bethany Llewellyn and Shay Callahan will attend the International Wildland Fire Association's Fire and Fuels conference the week of April 15<sup>th</sup>
  - o Adriana Rodriguez and Shay Callahan attended a Forest Service Timber Prep training in Redding in March. This will be helpful for our stewardship work with the forest.
- Cal Fire Forest Health: Forest Health crews wrapped up cutting and piling treatments in the Weaver Basin and prescribed fire assistance in the Reading Indian Creek, Little Browns Creek, and Glennison Gap areas. One contract for work in the Weaver Basin has been awarded, and additional contracts are in development for work in the Weaver Basin and Reading Indian Creek areas. One of these is a formal bid that will come to the board next month. This is the final year of this project and we will be working hard to spend all remaining funds.
- <u>Westside Timber Sale Prep:</u> Forestry technicians will work on flagging contracts in the Weaver Basin and cruising the Trinity Camps project under this funding source this spring.
- <u>Willow Creek Storm Recovery (HC):</u> The remaining funds are under contract with the Watershed Research and Training Center.
- <u>Fee for Service</u>: The fuels crew has been working around the Trinity Knolls water tanks under a Fee for Service agreement with the Trinity Center VFD.
- The McConnell Foundation (TMF): We expect the go-ahead for implementation in late summer. In the meantime, we will begin flagging treatment boundaries and exclusions. We are working with The McConnell Foundation to prioritize treatment areas and prepare a contract.
- Six Rivers National Forest Road Maintenance Program: The letter to file for this work is nearly complete and will be signed by the ranger this month. Implementation funds are being cobbled together and work should begin this summer.
- Middle Trinity Fuels Reduction Phase 1: Outreach has begun for this portion of the project.
   CEQA is underway for burning in the Junction City park (which requires archeological surveys)
   and treatment of the State Lands Commission parcel east of Weaverville. Two days of
   archaeological surveys were completed last month under contract with Mark Arnold, with
   support from Forest Health staff.
- <u>Ballpark Collaborative Prescribed Burning:</u> We are working with the Forest Service to develop interpretive signage for this burn site. We hope to have a spring burn window.
- <u>CARCD CAL FIRE Workforce Development Grant:</u> This funding supported staff time to complete Basic 32.
- <u>USFS Stewardship Agreement:</u> Joint Chiefs funding from this agreement is bolstering our Cal Fire funding in the Weaver Basin. This spring, it funded removal of hazard trees along Blue Rock Road. Small additional fuels projects are planned for the Weaver Basin.

- Northern Trinity Forest Resilience Partnership Phase II: We received notice that our Forest Health application to Cal Fire this round will be funded. The proposal was for approximately \$6 million and includes Forest Service, SPI, and private land in the upper Trinity watershed. It will be several months before this agreement is executed and we look forward to beginning work on this project.
- <u>Trinity County Resource Advisory Committee:</u> Our proposal for Community Chipping in partnership with the Watershed Research and Training Center was recommended for funding.

### 5.7 <u>Trinity County Fire Safe Council (TCFSC) – Skylar Fisher & Miles Raymond</u>


- <u>Trinity County Evacuation Plan:</u> Evacuation routes maps are being prepared for community member review at the May and June community meetings. We purchased 200 address signs and posts for distribution at the upcoming community meetings.
- <u>Trinity County Hazard Mitigation Plan:</u> We received two rounds of comment from CAL OES on the hazard mitigation plan. The second round of revisions are still being completed. We anticipate a May 1-July 1 public comment period.
- <u>Community Wildfire Protection Plan:</u> Public and partner outreach have begun for the community meetings. We are working on a StoryMap website to be an interactive hub for information regarding the CWPP and maps regarding wildfire risk in Trinity County. We've begun outreach to partners to have updated project mapping. A literature review has begun for the CWPP.
- <u>Trinity County Firewise Fair:</u> Planning continues for the Firewise Fair on May 11 at the Hayfork Park (10AM-3PM). There will be live music, goats, resource booths, CWPP map activities, free tacos, the fire mountain activity, and vendors.
- <u>Trinity County Firewise Education:</u> A month-long series of Firewise education lessons have begun at Hayfork Elementary and Van Duzen Elementary.
- Neighborhood Ambassador Program: There will be a Trinity Village invasive plant pull event on May 4. There will be a Coffee Creek fuels reduction event on May 16.
- <u>Trinity County Fire Safe Council Meeting:</u> The March Trinity County Fire Safe Council meeting had 30 attendees. The next meeting is April 25. Meetings are on the fourth Thursday of the month at the Trinity County Resource Conservation District conference room at 1 PM.
- <u>Social Media:</u> In the past 28 days, the Trinity County Fire Safe Council Facebook reached 8,842 accounts, got 683 engagements, and gained 5 new followers. The top post during this time was a BLM burn notification which reached 5,116 accounts.
- Greater Willow Creek Wildfire Resilience Project: Mailers were sent out to get landowner
  agreements to complete fuels reduction on undeveloped lots in Trinity Village and roadside
  shaded fuel breaks on SuzyQ Rd. Within a week, we have already received 6 signed
  agreements and multiple phone calls expressing interest from landowners to engage in the
  project.
- <u>Post-Fire Recovery:</u> As of the day of writing this update, mailers have been sent out to Trinity County private landowners who were impacted by the 2022 Lightning Complex to engage them in post-fire recovery planning and implementation work.

- <u>Trinity County Fair:</u> Miles is working with the USFS Wildfire Crisis Strategy (WCS) team to have a shared booth space at the Trinity County Fair this year. The current plan is to have a WCS table, TCRCD table, TCFSC table, and a CWPP map drawing activity table.
- <u>Collaboration</u>: The TCFSC will have a booth at the Plant and Seed Exchange on April 20, the Downriver VFD Open House on May 4, and the Willow Creek Firewise Fair on May 18. The TCFSC will have a monthly table at the Weaverville Farmers' Market when it starts up. Miles will be supporting the Lower Trinity River Prescribed Burn Association's Good Fire Symposium on April 21.
- Wildland Fire Assessment Program: The TCFSC will be hosting home assessment trainings on May 18 in Trinity Center to train Trinity Center and Coffee Creek VFD personnel and on May 25 in Hayfork to train Hayfork VFD and Douglas City VFD personnel. We are currently working with the Downriver VFD to schedule a future training at their VFD.

#### 5.8. Young Family Ranch

- Stewardship and Maintenance: Spring maintenance occurred in the garden areas of the
  ranch. Garden beds were weeded, tilled, and amended with aged manure donated from
  the Mule barn at the Shasta-Trinity Forest Service a year ago. All walkways and open
  spaces in the upper garden were mulched with cardboard and chips donated from
  Watkins Tree Service last year.
- Weaverville Summer Day Camp: Camp is in the planning phase.


<u>15<sup>th</sup> Annual Plant and Seed Exchange:</u> Scheduled for April 20th, from 10:00 AM to 2:00 PM, this event will host various informational booths, a local organic food vendor, live music, various



presentations, and plant and seed exchanging.

### 5.9 Geographic Information Systems (GIS) Manager's Report- Denise Wesley

- Trinity County Department Planning, Building Dept., and Department of Transportation (DOT): Land records, and addressing data were updated and provided to all county partners. The Parcel Viewer was updated with the newest parcel service and address updates. Address & parcel attribute verifications and/ or updates were made for 33 parcels.\_A Snow Load Lookup tool was created for the Building Department to assist them with a common workflow for finding snow load information by parcel. They have reported that this tool is working well for their needs. GIS Pro licenses were updated for most users in the county this month, and a training plan was developed with Esri assistance.
- <u>Fee for Service</u>: Coordination of data and cartographic layout services were provided for the North Trinity Lake Wildfire Response Plan, and for Kenneth Baldwin in support of NRCs projects.
- Fire Safe Council (FSC): Evacuation route mapping continued this month, with much progress. The routes are currently being put into cartographic layout for markup & input at upcoming community meetings. USFS projects were entered into the partner projects database. I built a prototype Evacuation Zone Lookup tool based on feedback from Skylar. I also provided her with a cost analysis for work billed to the FSC since January 1<sup>st</sup>, with anticipated future costs for anticipated work on evacuation route mapping, evacuation zone maintenance and CWPP mapping. I also updated the Fire History map for the annual Trinity Wildfire Journal article. The Trinity County Wildfire History Story Map is being developed to tell the story of how wildfire has driven RCD fuel reduction efforts in the community. Here is a preview:



- <u>Hazard Mitigation</u>: I provided updated Earthquake, Landslide, Flood & Wildfire maps, metadata, and analysis in support of the Hazard Mitigation Plan.
- <u>Outreach & Education</u>: In March, I attended refresher training on Field Mapping in preparation for the Trinity River Pollinator Habitat Enhancement & Restoration Project. I also worked with Esri to develop a GIS training plan for RCD IS users.
- <u>Trinity County Office of Education (TCOE)</u>: The TCOE Needs Assessment Data Dashboard is now live, and can be viewed <u>here</u>. For this project, I worked closely with TCOE Early Childhood Education staff to develop an online web product for hosting assessment results.

- <u>Travis Ranch BDA (Beaver Dam Analog):</u> I provided GIS support (Analysis) to Annyssa for woody debris locations based on data from the Beaver Restoration & Assessment Tool (BRAT) model.
- <u>Project Development:</u> I attended a webinar Women as Agents of Change, hosted by the California Natural Resources Agency (CNRA). I provided mapping support to Kelly for a North Coast RCD Collaborative proposal. I also attended the quarterly North state GIS Council Meeting.

### 6.0 Education and Outreach – Duncan McIntosh

### 477 - Bureau of Reclamation TRRP Outreach & Education:



- Science on Tap: The March Science on Tap event was hosted by Trinity County Brewing Company and featured Seth Naman's presentation titled "The Importance of Natural Flows to the Trinity River Salmon and Steelhead Populations Approximately 65 attendees enjoyed this engaging presentation. The next Science on Tap, scheduled for April 24th, will showcase Ken DeCamp presenting "Klamath Mountain Wildflowers"
- ♦ Trinity River Open House:
  The event at Junction City
  Elementary School (JCS) was

successful and informative. It provided specialists to address questions and concerns regarding various Trinity River Restoration Program projects and approaches. Additionally, the event featured watershed art created by JCS students. We also visited every class to provide watershed lessons.

Watershed Wednesday: Burnt Ranch Gorge

Burnt Ranch Gorge, located in Northern California's Klamath Mountains, is a geological wonder that cradles a biodiverse ecosystem along the Trinity River. This gorge stands as a testament to dynamic earth processes, displaying a variety of rock formations, including ancient metamorphic rocks and distinctive serpentine and ultramafic rocks, which lead to unique serpentine soils. These geological characteristics provide habitats for salmon and steelhead trout, which are vital for local wildlife, including river otters and bald eagles.

The serpentine soils are especially significant for supporting unique plant communities with rare endemic species. The California pitcher plant (Darlingtonia californica) thrives in these challenging conditions, and the serpentine sunflower (Helianthus exilis) is uniquely adapted to the mineral-rich soils. Amid its ecological and geological richness, Burnt Ranch Gorge is famous for its challenging Class IV and V rapids, attracting experienced kayakers to navigate its turbulent waters and offering a blend of adventure with natural beauty.







#### PROBATION AND DISQUALIFICATION


